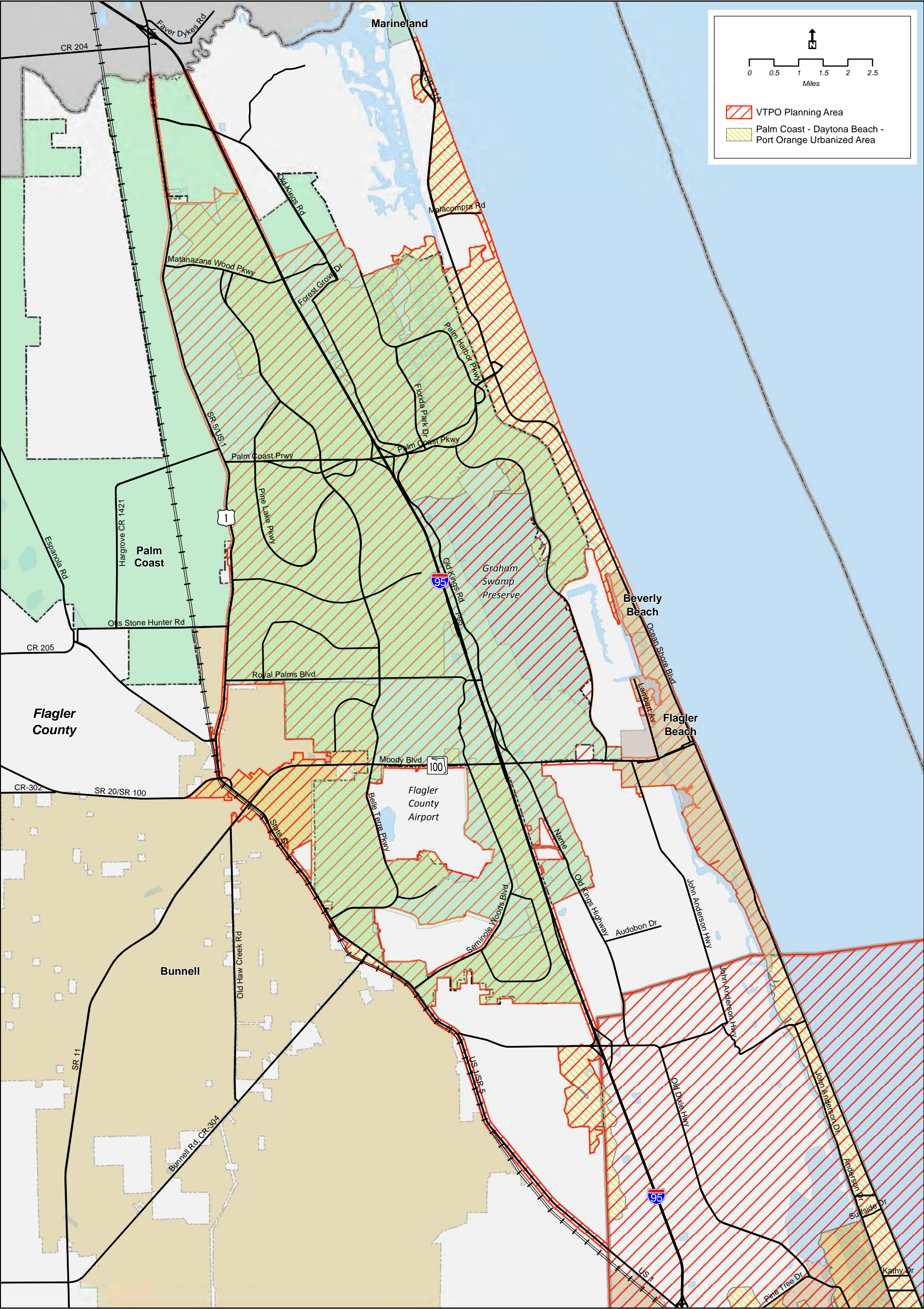
## Volusia TPO Planning Area Boundary – DRAFT 12/31/12

- I. All of Volusia County and
- II. That part of Flagler County described as follows:
  - A. All of the area designated by the US Census Bureau as the 2010 Palm Coast – Daytona Beach – Port Orange Urbanized Area and, in addition,
  - B. All of the area within the Palm Coast city limit as of 12/18/12 lying east of SR 5/US 1, excepting therefrom the areas described as follows:
    1. Exception Area #1 – that area bounded on the north by the Flagler/St Johns County Line, on the east by SR 9/I-95, on the south by the Matanzas Golf Course and Blocks 163 and 164 of Palm Coast Map of Lakeview, Section 37, according to the Plat thereof as recorded in Plat Book 13, Pgs 1 through 29, inclusive, of the Public Records of Flagler County, FL, and on the west by SR5/US 1;
    2. Exception Area #2 – that area bounded on the north and east by the Palm Coast city limit, on the south by a line bearing N57°17'44.80"W and crossing Old Kings Rd at a point 2,600 feet north of the intersection of Matanzas Wood Pkwy and Old Kings Rd as measured along Old Kings Rd, and on the west by SR 9/I-95; and
  - C. That part of SR 5/US 1 extending from the Flagler/St Johns County Line to the Flagler/Volusia County Line; that part of SR 9/I-95 extending from the Flagler/St Johns County Line to the Flagler/Volusia County Line; that part of SR 100 extending from SR 5/US 1 to SR A1A; all of Malacompra Rd; all of Belle Terre Pkwy; all of Royal Palms Blvd; all of Seminole Woods Blvd; that part of Old Kings Hwy extending approximately 15,350 feet south from SR 100 to a point of intersection with the Palm Coast city limit, that part of Old Dixie Hwy extending approximately 4,300 feet westerly from SR 9/I-95 to a point of intersection with Plantation Bay Dr, all of Colbert Ln, and all of Lambert Av.

The purpose of this correspondence is to inform the TPO that the City of Bunnell has interest in formalizing its participation with the Volusia County TPO. The City intends on beginning the process of building our relationship by working together on three issues that need to be addressed to become further connected with the Volusia County TPO.

Over the past year or so we have performed our due diligence by investigating various options and attending several forums, during which we have never taken a formal position on any TPO organization. However, the City Commission has now taken a formal position to join the TPO and is respectfully requesting to meet with your staff and whomever else we may need to meet with to pursue this partnership.

3. The City is requesting a seat in the Flagler County small city rotation.
