1. Call to Order / Roll Call / Determination of Quorum/Pledge of Allegiance

Citizens Advisory Committee (CAC) Chairperson Greg Feldman called the meeting of the Volusia-Flagler Transportation Planning Organization (TPO) Citizens Advisory Committee (CAC) to order at 1:16 p.m. The roll was called, and it was determined that a quorum was physically present. The meeting was held in a hybrid format with

fifteen voting members and two non-voting members physically present, and one voting member and one non-voting member virtually present.

The Pledge of Allegiance was given.

MOTION: *Mr. Storke made a motion to allow virtual participation. The motion was seconded by Mr. Josvai and carried unanimously.*

2. Public Comment/Participation

There were no public comments.

3. Action Items

A. Review and Approval of the November 18, 2025 CAC Meeting Minutes

MOTION: *Mr. Persad moved to approve the November 18, 2025 CAC minutes. The motion was seconded by Ms. Nice and carried unanimously.*

B. Nomination and Election of TCC Chairperson for the remainder of FY 2025/26 term (TCC Only)

This item was for the TCC only.

C. Review and Recommend Approval of Resolution 2026-## amending the FY 2025/26 to FY 2029/30 Transportation Improvement Program (TIP) (Roll Call Vote Required)

Ms. Nicoulin explained that the TIP needs to be amended for the inclusion of two projects. She discussed the projects, stating that the first is for the purchase of VoTran vehicles, and the second project received additional funding for the PD&E study on I-4, between SR 472 and I-95.

Ms. Karl asked if the PDE study was partially funded. Ms. Nicoulin stated that there is \$5,000 for department in-house overhead, and that additional federal funds were received. Ms. Karl asked if this study is part of the Beyond the Ultimate project. Ms. Nicoulin explained that a portion of it is included in Beyond the Ultimate.

MOTION: *Mr. Williams made a motion to recommend approval of Resolution 2026-## amending the FY 2025/26 to FY 2029/30 Transportation Improvement Program (TIP). The motion was seconded by Mr. Storke and carried unanimously by roll call vote.*

D. Review and Recommend Approval of Resolution 2026-## adopting the 2026 Volusia-Flagler TPO Safety Data and Targets

[Handout provided]

Ms. Nicoulin explained that the Federal Highway Administration dictates that annually, the safety data and targets must be adopted. Data regarding fatalities and serious injuries is recorded and documented. She stated that the TPO has established the same safety targets as the state, targets of zero, which align with the Vision Zero Action Plan.

Ms. Nice asked if there have been any changes that resulted in the significant drop in fatalities and serious injuries. Ms. Nicoulin stated that a deep dive into the data has not yet occurred.

Mr. Feldman asked how the procedure changes if the TPO does not adopt the same goals as the state. Ms. Nicoulin explained that the TPO would then have to compile its own data and report it to the state; however, she noted that there is no gain or penalty for adopting the state's targets. She reviewed the data provided in the handout.

MOTION: *Mr. Persad made a motion to recommend approval of Resolution 2026-## adopting the 2026 Volusia-Flagler TPO Safety Data and Targets. The motion was seconded by Ms. Karl and carried unanimously.*

4. Presentation Items

A. Presentation and Discussion of the Volusia-Flagler TPO FY 2026/27 to FY 2027/28 Unified Planning Work Program (UPWP)

Ms. Nicoulin stated that the TPO is in the process of drafting the FY 2026/27 to FY 2027/28 UPWP, explaining the concept and purpose of the document. It is expected to be adopted in May. She remarked that the recent adoption of major projects like the Vision Zero Action Plan (VZAP) and the Long Range Transportation Plan (LRTP) allows staff to focus their efforts on new projects. She let the committee know that staff is requesting input regarding potential projects to be included in the next UPWP.

Mr. Feldman recommended that committee members speak to their respective jurisdictions about potential projects. Ms. Nicoulin mentioned that this conversation would also take place at the Board meeting next week.

Mr. Persad asked for clarification regarding annual outreach activities. Ms. Nicoulin explained that Ms. Blankenship puts together a schedule of activities involving community outreach, many of which occur every year. She stated that anyone with an event suggestion should reach out to Ms. Blankenship.

Discussion ensued regarding education around e-bike safety.

B. Presentation and Discussion of the 2026 Call for Projects Workshop (TCC Only)

This item was for the TCC only.

C. FDOT Report

Ms. Powell presented the FDOT Report. She shared a video detailing the new roundabout near Cody's Corner, indicating that, since its installation, there have been no serious injuries or fatalities. She also stated that January is National Move Over Month. She mentioned that she would look into FDOT's resources regarding e-bikes.

D. Volusia and Flagler County Construction Reports

The Volusia County and Flagler County Construction Reports were provided in the agenda.

5. Staff Comments

Ms. Blankenship thanked everyone who attended the Holiday Open House and/or donated a toy. She offered special thanks to Mr. Persad and Ms. Karl for their help.

6. CAC Member Comments

Ms. Lendian expressed her appreciation for the new roundabout in DeLeon Springs.

Ms. Nice stated that more information regarding e-bike safety would be helpful.

Ms. Deyette asked about the classification of Saxon Boulevard in Deltona. Ms. Nicoulin stated that she would take a look and would coordinate with FDOT regarding interchange improvements.

Ms. Nice expressed her excitement for a new technology being implemented to alert police departments when a car drives down the "wrong way" ramp.

Mr. Persad mentioned that VoTran is making significant changes beginning March 1st and he would share the locations where education will occur.

Mr. Mykytka asked who manages the traffic signal projects in Flagler Beach at SR 100 and stated that the mast arm fell down. Ms. Powell said that she would get him that information.

Mr. Williams asked where the reductions occurred within the safety data. Ms. Nicoulin stated that the VZAP looked at the historical data and identified trends and projects.

Mr. Feldman noted that I-95 fatalities and serious injuries were included in the data presented and, when that information is extrapolated, the fatalities and serious injuries decrease.

Mr. MacFarlane expressed concern about a merge lane on Saxon Boulevard in Deltona. Ms. Powell stated that she would look into it.

Ms. Divina asked about a crosswalk project at Chapel Street and Moody Boulevard in Bunnell. Ms. Powell stated that she would get the information to her.

1. Call to Order / Roll Call / Determination of Quorum

Technical Coordinating Committee (TCC) Vice Chairperson Simone Kenny called the Volusia-Flagler Transportation Planning Organization (TPO) Technical Coordinating Committee (TCC) meeting to order at 3:00 p.m. The roll was called and it was determined that a quorum was physically present. The meeting was held in a hybrid format with seventeen voting and one non-voting member physically present, and two voting members virtually present.

MOTION: *Mr. Heseler made a motion to allow remote participation. The motion was seconded by Mr. Ruiz and carried unanimously.*

2. Public Comment/Participation

There were no public comments.

3. Action Items

A. Review and Approval of the November 18, 2025 TCC Meeting Minutes

MOTION: *Mr. Heseler moved to approve the November 18, 2025 TCC minutes. The motion was seconded by Ms. Witte and carried unanimously.*

B. Nomination and Election of TCC Chairperson for the remainder of FY 2025/26 term

Ms. Nicoulin explained that Mr. Holmes retired earlier in the month; therefore, a new TCC Chairperson would need to be selected for the remainder of the FY 2025/26 term. She stated that if the current Vice Chair were to be elected as Chair, then a new Vice Chair would also need to be elected.

MOTION: *Mr. Papa nominated Ms. Kenny for TCC Chairperson for the remainder of the FY 2025/26 term. She accepted the nomination and the vote was unanimous.*

MOTION: *Ms. Witte nominated herself as Vice Chair of the TCC for the remainder of the FY 2025/26 term. The vote was unanimous.*

MOTION: *Ms. Witte made a motion to recommend approval of Resolution 2026-## amending the FY 2025/26 to FY 2029/30 Transportation Improvement Program (TIP). The motion was seconded by Mr. Carson and carried unanimously by roll call vote.*

D. Review and Recommend Approval of Resolution 2026-## adopting the 2026 Volusia-Flagler TPO Safety Data and Targets

Ms. Nicoulin explained that the Federal Highway Administration dictates that safety data and targets must be adopted within 180 days from the date that FDOT adopts theirs. Data regarding fatalities and serious injuries was reviewed by Ms. Nicoulin. She stated that the TPO has established the same safety targets that were adopted by the state, a target of zero, which aligns with the TPO's Vision Zero Action Plan.

Mr. West commented his surprise that 2020 was the peak of the crash data as it was during COVID-19. Ms. Nicoulin stated that less traffic congestion on the roadways allowed for increased speeds, which led to more crashes and deaths.

MOTION: *Mr. Heseler made a motion to recommend approval of Resolution 2026-## adopting the 2026 Volusia-Flagler TPO Safety Data and Targets. The motion was seconded and carried unanimously.*

4. Presentation Items

A. Presentation and Discussion of the Volusia-Flagler TPO FY 2026/27 to FY 2027/28 Unified Planning Work Program (UPWP)

Ms. Nicoulin stated that the TPO is in the process of drafting the FY 2026/27 to FY 2027/28 UPWP, and explained the concept and purpose of the document. It is expected to be adopted in April. She remarked that the recent adoption of major projects like the Vision Zero Action Plan (VZAP) and the Long Range Transportation Plan (LRTP) allows staff to focus their efforts on new projects. She let the committee know that staff is requesting input regarding potential projects to be included in the next UPWP. The CAC recommended education regarding e-bikes and the BPAC recommended looking at a bicycle/pedestrian connectivity gap study across the two counties and updating the Bicycle Suitability Map into a digital format.

Mr. West suggested updating the Transportation Impact Analysis (TIA) Guidelines.

B. Presentation and Discussion of the 2026 Call for Projects Workshop

Ms. Nicoulin stated that the annual Call for Projects opened on December 1st and noted that there were not many changes in the applications from the prior Call for Projects. She stated that the call closes on February 27th at 4:00 p.m. and advised members to have everything uploaded by then in one PDF. She explained that projects will be ranked based on criteria created by the subcommittees. She added that the TPO staff was available to review applications for completeness prior to their submittal.

Mr. Steele asked if letters of support should be included. Ms. Nicoulin stated that letters of support and cost estimates should be provided.

Mr. Calderin asked about the scope for planning studies. Ms. Nicoulin stated that there is no dedicated funding source for that list, as the studies are funded through FDOT and typically need to be on a state road. She said that she would discuss more information with him after the meeting, as an application may be a better fit as a feasibility study.

Ms. Nicoulin mentioned that the Call for Projects webpage on the TPO website has everything necessary to submit an application.

Ms. Powell presented the FDOT Report. She shared a video detailing the new roundabout near Cody's Corner, indicating that, since its installation, there have been no serious injuries or fatalities. She also stated that January is National Move Over Month.

SUMMARY BACKGROUND:

The Unified Planning Work Program (UPWP) outlines the annual activities and funding for the TPO over a two-year period. The next two-year UPWP will become effective July 1, 2026. The TPO's transportation planning activities are funded in large part through federal grants. These federally funded transportation planning activities must be identified and approved by the Federal Highway Administration (FHWA) and FDOT in advance of each fiscal year. The activities, products, and budgeted funds must be documented in the TPO's Unified Planning Work Program (UPWP) which is updated every two years.

At last month's meeting, TPO staff reviewed the draft tasks for consideration. TPO staff will provide an update on the recommended tasks and activities to be included in the draft FY 2026/27 and FY 2027/28 UPWP for FDOT/FHWA review.

The Florida Department of Transportation (FDOT) is constructing a two-lane roundabout at the intersection of State Road (S.R.) 44 (East New York Avenue) and Kepler Road in DeLand, Volusia County, to enhance safety and improve the flow of traffic.

Once completed, the roundabout will replace the existing signalized intersection. The roundabout will also have two travel lanes in each direction with right-turn bypass lanes at three of the four road connections, a concrete apron to accommodate large trucks, and landscaping in the center island.

Pedestrian safety enhancements include new sidewalks and crosswalks equipped with Rectangular Rapid Flashing Beacons (RRFBs) at the roundabout approaches. Each RRFB will include flashing yellow LED lights to increase drivers' awareness of pedestrians crossing at the roundabout. For more information about RRFBs and how to use them, visit:

S.R. 44 will also be resurfaced from approximately 800 feet west of Kepler Road to Talisman Road. Kepler Road will be resurfaced from 650 feet south of S.R. 44 to 1,250 feet north of S.R. 44. Additionally, a center bi-directional turn lane will be added along S.R. 44 from east of Kepler Road to Lake Winnemissett Drive.

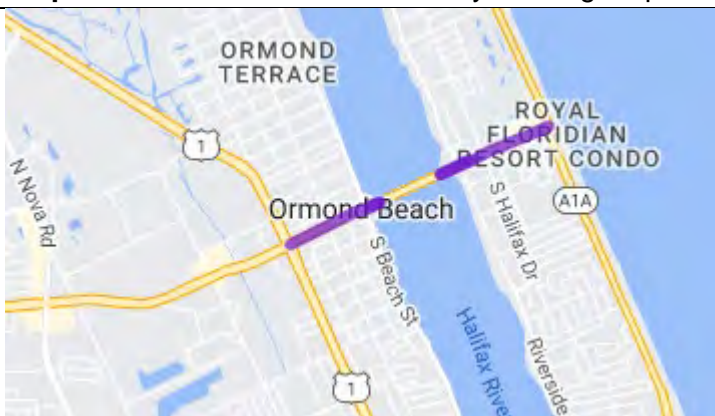

In addition to repaving this segment of S.R. 40, the travel lanes along this segment of Granada Boulevard will be slightly narrowed to 10 feet, and subtle changes in the roadway alignment will be introduced to encourage slower driving speeds. Pedestrian safety improvements include a new mid-block pedestrian crossing between Vining Court and Bovard Avenue. Upgrades will also be made to existing crossings at Washington Street and west of Beach Street.

The mid-block crossings located west of Beach Street and between Vining Court and Bovard Avenue will be slightly elevated to be level with the sidewalk and will include in-road lighting to further alert motorists of people crossing the roadway and encourage reduced speeds.

All three crossings will be equipped with a Pedestrian Hybrid Beacon (PHB) and overhead lighting to increase driver awareness and visibility of pedestrians. - Walnut Avenue Paving Project – 100% Design is complete. Plans finalization was concluded in November 2025 and accepted by the Department. USACOE permitting is ongoing.
- Westmayer Place Paving Project – Final Design is complete and has been accepted by the Department.
- Canal Avenue (CR 302) from Water Oak Road to Forest Park – Final design is complete and has been accepted by the Department. Contract and grant are in the process of closeout. Public meeting was held on November 4, 2025, at Hidden Trails Park in Daytona North.
- Jungle Hut Road from A1A to beach access – 100% design plans received and are under review. Plans finalization and permitting are anticipated to conclude in February 2026. Community Meeting was held on September 30, 2025, 5-7pm at Hammock Community Center.
- Forest Park Street from CR 90 to SR 100 – 60% design plans received and are under review. Community Meeting was held on November 4, 2025, 5-7pm at Hidden Trails Community Center in Daytona North. Plans finalization and permitting are anticipated to conclude in July 2026.
- Flagler Central Commerce Parkway Connector Project – Construction of the roadway project is complete and was accepted by the County and the Department in September 2025. Project closeout activities are currently underway.
- Old Haw Creek Road – Final Inspection and acceptance of construction was on July 17, 2025. Contract is in the process of closeout and preparation of final invoice for reimbursement. Staff is coordinating with FDOT to receive reimbursement of expenses incurred during construction coordination with FDOT's adjacent SR11 project. Supplemental Agreement was approved by the BOCC on December 15, 2025. Final reimbursement request is being prepared for submittal.
- CR 205 Resurfacing Project – Required design update was finalized in preparation of construction contractor procurement. Funding Agreement was approved by the BOCC on December 15, 2025. Advertisement for Bid is planned for early 2026. Construction is anticipated to commence in the second quarter 2026.



- CR 304 Resurfacing Project (CR 305 to SR-11) – Design Plans update and permit activities are anticipated to begin in the second quarter 2026. Construction is anticipated to commence in the third quarter 2026.
- First Avenue Phase 2 Drainage – 90% Design plans received and are under review. Community Meeting was held on September 30, 2025, 5-7pm at Hammock Community Center. Plan finalization is scheduled for January 2026.

Sidewalk & Trail Program

- Bulow Creek Headwaters Regional Park – Planning phase is underway with the first public meeting held on June 4, 2025. Presentation/Update to County Commission was made at a BOCC workshop on September 15, 2025. A public meeting is scheduled for February 3, 2026. Planning efforts are anticipated to conclude in Summer 2026 when the project will transition into design & permitting.
- Trailhead for GST & Lehigh Trail – Coordination with the Department's CSC is underway and is being coordinated with planned Eco-Discovery Center. Design phase is anticipated to begin in the first quarter 2026.
- Old Kings Road South Trail (SR100 to County Line) – Design began in July 2025, and a 60% design submittal is anticipated in January 2026. Completion of design and permitting is anticipated by September 2026.

Vertical CIP Program

- Fire Rescue Station 51 – Construction Notice to Proceed was issued on November 19, 2025. Groundbreaking ceremony was held on December 8, 2025, 11am-12pm. Contractor was mobilized onsite and construction is underway.
- Fire Rescue Administration Station 50 – Construction Notice to Proceed was issued on October 8, 2025. Groundbreaking ceremony was held on November 13, 2025, 10-11am. Contractor was mobilized onsite and construction is underway.
- NEXUS Center – Substantial Completion date was September 25, 2025. Certificate of Occupancy was received in December 2025. Final construction and project closeout are underway.



- SMA Integrated Stabilization Unit – Construction Notice to Proceed was issued on October 22, 2025. Groundbreaking ceremony was held on November 18, 2025, 1-2pm. Contractor was mobilized onsite and construction is underway.
- Eco-Discovery Center – The BOCC approved award of Design-Build contract to The Collage Companies on September 15, 2025. Design kick-off meeting held on January 26, 2026. Design-Builder has commenced preliminary design to establish the scope of the project.
- Multipurpose Emergency Preparedness Project – Task Work Order Four was issued to Design Build Team. This is the final Task Work Order needed to complete construction of all remaining work by June 30, 2026. Contractor was mobilized onsite and construction is underway.

Stormwater Master Plan Program

- MalaCompra Canal Restoration and Resiliency – Design and Permitting phases are underway. Conceptual design phase was completed. Project completion is anticipated in July 2026.

Beach Management Plan Program

- Beach Reach 2 (North 7th St to Varn Park) – All permits have been received. Invitation to bid will be released in first quarter of 2026 and construction timing will depend on the contractor's schedule. Contract will specify that the dredge project must be complete by the end of 2026.
- Beach Reach 3 – The Professional Services Agreement with Moffatt & Nichol was approved by the BOCC on April 21, 2025. Field work for permitting studies began in May 2025 and continues. Project design activities are actively underway. Hardbottom mapping has been delayed due to field and weather conditions. An update was provided at the December 15th BOCC Workshop.
- Hammock Dunes Emergency Dune Restoration Project – Completed as of November 2025.
- Ocean Hammock/Hammock Beach and Golf Resort Emergency Dune Restoration Project – This interim emergency dune restoration project between Jungle Hut Road and the southern edge of MalaCompra park was authorized under the Emergency Final Order for



Hurricane Milton. Substantial completion was issued on December 15, 2025. The project is being funded jointly by FDEP and the OHPOA and HBAG Resort.

- FEMA Category G Dune Restoration Project – This emergency dune restoration project is underway from the southern end MalaCompra Park to River to Sea Preserve. Construction commenced on December 15, 2025, and is anticipated to continue through March 2026.

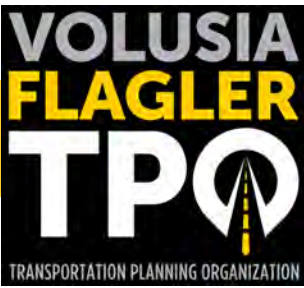

Volusia County Transit to Implement Service Changes March 1; Public Outreach Planned

January 22, 2026

VoTran will implement several route changes and replace some fixed-route service with VoRide beginning March 1. Volusia County's Transit Services Division will conduct upcoming public outreach events to inform riders about the changes.

Route Changes

East Volusia

- Route 1: The route will be eliminated. Service north of Granada Boulevard will be replaced by VoRide. Service on A1A between International Speedway Boulevard and Granada Boulevard will be replaced by Route 19.
- Route 3: The A, B and C branches will be eliminated. All trips will operate between the Transfer Plaza and the Thompson Creek Superstop near the intersection of Granada Boulevard and U.S. 1. Service north of Granada Boulevard will be replaced by VoRide.
- Route 10: Outbound trips will depart the Transfer Plaza at :35, with all subsequent timepoints adjusted by five minutes. Inbound trips will not change.
- Route 15: Off-peak service will be reduced to hourly departures from the Transfer Plaza. Peakhour service (6–9 a.m. and 3–7 p.m.) will continue every 30 minutes.
- Route 17: The A branch, serving areas south of Dunlawton Avenue to Ponce Inlet, will be eliminated and replaced by on-demand service through Uber Transit. Trips must be booked through the VoTran On Demand app. All trips will follow the current B branch and will be designated Route 17.
- Route 19: Service will increase to operate every 30 minutes.
- NSB Flex Service: The service will be converted to VoRide and will operate from 7 a.m. to 6 p.m.



- Night service: Night Service routes 3, 4, 10, 11 and 15 will be replaced by VoRide. A new Route 70 will operate from 7 p.m. to midnight, replacing Routes 1 and 17.

Public Outreach

Throughout February, Transit Services Division staff will be onboard affected routes and at the Transfer Plaza to inform riders of the changes. The division will also host three open-house style public meetings to provide additional information, including how to use the VoRide booking app.

- Feb. 12, noon–4 p.m.: Port Orange Regional Library, 1005 City Center Circle, Port Orange. Riders can use Route 12. Flyers detailing route and schedule changes will be available on all buses.
