I. <u>Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance</u>

The meeting of the River to Sea Transportation Planning Organization (TPO) Bicycle/Pedestrian Advisory Committee (BPAC) was called to order at 2:00 p.m. by Chairperson Jason Aufdenberg. The roll was called and it was determined that a quorum was physically present. Due to the COVID-19 virus, the meeting was held in a hybrid format with 12 voting and two non-voting members physically present; four voting and two non-voting members were virtually present.

The Pledge of Allegiance was given.

Chairperson Aufdenberg stated the members participating virtually are doing so as a result of social distancing restrictions associated with COVID-19. Rulings from the Florida Attorney General require that the members physically present take a vote to allow virtual participation due to "extraordinary circumstances".

MOTION: A motion was made by Ms. Belin to allow members attending virtually to participate and vote. The motion was seconded by Mr. Eik and carried unanimously.

II. <u>Public Comment/Participation</u>

There were no public comments.

III. Action Items

A. <u>Review and Approval of November 10, 2021 BPAC Meeting Minutes</u>

MOTION: A motion was made by Mr. Storke to approve the November 10, 2021 BPAC meeting minutes. The motion was seconded by Mr. Leal and carried unanimously.

IV. <u>Presentation and Discussion Items</u>

A. <u>Presentation and Discussion of FDOT's Safety Program</u>

Ms. Loreen Bobo, FDOT, gave a PowerPoint presentation of FDOT's Safety Program and their target of Vision Zero for fatalities and serious injuries; each project is reviewed to see what can be done to improve safety on the roadways. Safety projects must have a cost/benefit ratio; they only receive \$21 million for safety projects in District 5; however, safety measures are put into all projects. The safety office works with every FDOT department to improve safety and strive for zero fatalities. FDOT wants to provide a unified effort to greatly reduce crashes and the effects of crashes to ultimately get to zero fatalities and serious injuries. She reviewed FDOT's strategic plan's three foundations which include collaboration, infrastructure and education and explained each. She explained Vision Zero and noted there are federal resolutions being considered to reach that goal by the year 2050. Supporting slower speeds on roadways is one way to lower the statistics and she reviewed some countermeasures that assist in achieving slower speeds such as roundabouts, chicanes, raised crosswalks and narrower lanes. She reviewed ways that members could help such as encouraging safety enhancements in developments and permits. She explained the High Visibility Enforcement Program and encouraged members to get their police and sheriffs' departments to participate. She noted there are other available federal grant opportunities which support education and other efforts by local governments; ideas for safety mitigation or areas of concern can be shared on their website.

Members discussed the presentation; they questioned whether or not Volusia County has a safety plan which is unknown. It was announced that FDOT Highway Safety Improvement Program (HSIP) funding can be used on local roads; FDOT analyzes the cause factors and corridors where the highest incidents occur; and how FDOT informs the public of these locations. It was suggested FDOT reflect those high incident areas in their advertising and awareness campaign and to have a contact phone number for citizens to report hazardous conditions they see. Comments were provided regarding slowing speeds and how bike lanes are installed. FDOT looks at how to accommodate all modes and it depends on the corridor; they look to see what the community wants. Public meetings are held for nearly every project and comments can be provided on the cflroads.com which has every project they are working on as well as contact information for the project manager. Autonomous vehicles were discussed. It was suggested monitoring speeds between SunPass tolls to see which vehicles are speeding and inform the drivers. Ms. Bobo will look into the HSIP regarding what percentage of the new transportation funding bill can be used for bicycle/pedestrian facilities and provide that information.

B. Presentation and Discussion of Updated Safety Data and Targets

Ms. Nicoulin stated it is the time of year when the TPO reviews crash data to help establish safety targets for 2022; the targets are based on a five-year rolling average. It is a federal requirement to adopt safety targets for five performance measures; fatalities, serious injuries, non-motorized fatalities and serious injuries, rate of

fatalities and the rate of serious injuries. This is the fifth year the TPO has had to adopt these targets. FDOT has a target of Vision Zero meaning zero fatalities and serious injuries. The TPO supports FDOT's Vision Zero as a vision but the TPO's requirement is to adopt an annual target. In 2018, 2019 and 2020, the methodology used to establish the targets was based on a 2% annual reduction in each safety performance measure; a 2% reduction is what the TPO felt could be attainable. She explained that last year they continued to reduce that target by 2% when measures are trending downward; however, if the measure is trending upward, the previous year's target would be retained. This is the methodology used to set the targets for 2022. She reviewed the data and explained how the targets are set; the previous year's target for fatalities, non-motorized fatalities and serious injuries, and the fatality rate will be retained; the targets for serious injuries and rate of serious injuries were met so new targets will be set. Next month a resolution to adopt the 2022 targets will be presented for a recommendation of approval.

Members discussed the data in detail and it was explained again how the 2022 targets were set and where the data was obtained (Signal Four Analytics of the University of Florida). Members also discussed various solutions on how to meet the targets including collaboration with law enforcement and other agencies; strategies to reduce fatalities and serious injuries; and funding for safety projects. It was asked if there are special federal funds to help local communities to bring the numbers down since this is a federal requirement. Ms. Nicoulin explained not yet; the targets are reported to FDOT who reports to FHWA reviews to see if we are making progress toward our target; however, there are state safety funds available that can be used off-system. That program is specific to funding safety related projects and local municipalities do not have to go through the TPO's process. It was also asked if funding is attached to the data; if a community has higher numbers if there is more funding for safety projects; the TPO does not program the safety funds but staff will coordinate with FDOT for more information. It is was asked if the local communities within the planning area use Signal Four Analytics for their data. The TPO does not know but Ms. Winsett stated they are supposed to be. The TPO has used Signal Four Analytics consistently to be able to identify trends; other agencies have been using it as they have enhanced their data. Discussion regarding the data and targets continued; it was explained again how the targets were developed.

C. <u>Presentation and Discussion of Updated Transit Safety Data and Targets</u>

Mr. Harris gave a PowerPoint presentation of the updated transit safety data and targets; he explained MAP-21 and the FAST Act require transit agencies to develop a Public Transportation Agency Safety Plan (PTSAP) and a Transit Asset Management (TAM) Plan. He showed a video provided by The Federal Transit Administration (FTA) regarding these plans. There are three transit agencies within the TPO's planning area; Votran, SunRail and Flagler County Public Transportation. It is also a requirement for transit providers that are recipients of Federal Transit Administration (FTA) funds to set safety targets and update these targets annually. He explained that a PTASP is not required for SunRail due to FDOT's Safety Oversight Program or for Flagler County Public Transportation as they do not receive FTA Section 5307 funds. The TPO adopts the transit safety targets set by the transit operator (Votran). He reviewed the transit safety performance measures and data; fatalities, injuries, reportable safety events and system reliability. The goal is to use the plan to reach or maintain a state of good repair. He reviewed the asset categories of the TAM which include equipment, rolling stock, infrastructure and facilities. A resolution to update the transit safety targets will be back next month for a recommendation of approval.

V. <u>Staff Comments</u>

→ DeBary SUN Trail Project Ribbon Cutting Event

Mr. Harris announced Volusia County is planning a ribbon cutting for the SUN Trail project in DeBary; this is a portion of the Spring to Spring Trail and the St. John's River to Sea Loop. The ribbon cutting will be Friday, January 21, 2022 at 11:00 am at Rob Sullivan Park; 200 West Highbanks Road, DeBary.

Chairperson Aufdenberg asked if this trail will connect Lake Beresford Park to Titusville.

Mr. Harris replied yes; it is a continuous trail to Titusville.

→ Votran Service Changes

Mr. Harris announced Votran has implemented temporary service changes due to a driver shortage. He reviewed the changes and noted the details are provided in the agenda. Votran is currently actively recruiting drivers.

\rightarrow 2021 Bipartisan Infrastructure Law

Mr. Harris stated the 2021 Bipartisan Infrastructure Law details for Florida are provided in the agenda. Most notable is USDOT has introduced a new program: Safe Streets for All. It will provide additional funding to local and tribal governments in Florida to support their efforts to advance the Vision Zero plan and other improvements to reduce crashes and fatalities especially for bicyclists and pedestrians.

\rightarrow 2022 Call for Projects

Mr. Harris stated the TPO's 2022 Call for Projects continues; it opened December 3, 2021 with a deadline to submit projects of February 25, 2022. There are four bicycle/pedestrian studies currently underway through the TPO's consultants; hopefully, these studies will be finalized this month so the local governments can apply for projects recommended in the studies.

Mr. Harris announced FDOT is holding a public meeting today to discuss safety improvements along SR A1A in Ormond Beach; it is at 5:30 pm at the Casements, 25, Riverside Drive, Ormond Beach. This project is on the TPO's priority list.

Ms. Nicoulin announced that the TPO received the Outstanding Planning Study Award from the Florida Planning and Zoning Association (FPZA) for the Paratransit Service Analysis; Mr. Harris was the Project Manager.

Mr. Daun referred to the new Complete Streets for All program and asked if in order to receive funding local governments will need a Vision Zero plan or safety plan.

Mr. Harris replied he believes so but is not positive; the law is new and staff is still reviewing the details. He will have another update next month.

Mr. Harris referred to the 2023-2027 Florida Greenways and Trails Systems (FGTS) Plan update and stated they did not implement the TPO's recommended updates to the plan; he will be meeting with them to discuss it. It is a probability that he will develop new updates to submit this year; he will bring those to the BPAC and the TPO Board for approval in the next few months.

VII. BPAC Member Comments

Ms. Moss announced FDOT is holding a public meeting regarding the Mason Avenue Corridor Planning Study on Wednesday, January 19, 2022 at 5:30 pm at the Midtown Cultural and Education Center in Daytona Beach; it will be a hybrid meeting. She announced that Oslo, Norway claims to have reached Vision Zero in 2019. The Community Traffic Safety Teams (CTST) encourage law enforcement agencies to participate in the High Visibility Enforcement Program; however, law enforcement agencies are understaffed and are unable to do so at this time.

Mr. Daun provided comments regarding the new Amazon warehouse on the Bellevue Avenue extension and the proposed east/west trail to DeLand. Volusia County will have to do due diligence and conduct traffic pattern and

capacity studies and include bicycle/pedestrian facilities because that was going to be the east/west trail to DeLand. It is a county road which is why he asked Ms. Bobo about using safety funds on local or county roads because this could be a potential issue. He wants to contact FDOT or Volusia County regarding the intersection of US 1 and Fairview Avenue (County Road 4040) because of the construction of apartments it is becoming a major east/west link as people do not want to use LPGA Boulevard or International Speedway Boulevard; there is no green arrow turn signal to turn onto US 1.

Mr. Dodzik announced he and Mr. Coletti attended the Call for Projects meeting in Palm Coast this morning; there was good representation from Palm Coast and Flagler Beach. There was a good discussion and all want to be more proactive and accomplish projects.

Mr. Harris asked if they were going to submit applications to the TPO through the Call for Projects this year.

Mr. Dodzik replied it appears that way; either collectively or individually. His understanding is that this TPO only covers a portion of Flagler County but rest of the county has another TPO.

Mr. Harris replied the R2CTPO serves the entire urbanized area in Flagler County; the rest of Flagler County has to work directly with FDOT for the unurbanized areas. There is not another TPO in Flagler County.

Ms. Winsett announced that for traffic signal improvements or other issues within Volusia County, the best way to get something done is to go to <u>www.Volusia.org</u> to the service request page and put the request in writing. It gives citizens the opportunity to explain what the problem is and what they would like to see done; routes the request to the appropriate department. There is not the perfect Volusia County employee to address committee members questions and/or concerns regarding engineering, funding, programs, etc.; she does her best but members should put their requests and/or concerns in writing to the elected officials and managers. If members cannot find the correct page on the website they can contact her for assistance.

Chairperson Aufdenberg announced that on Saturday he got a sneak peek at the Daytona Beach Riverfront Esplanade which is the reconstructed East Coast Greenway and a section of the St. John's River to Sea Loop. He walked the entire length from Beach Street to New Smyrna Beach and it is scheduled to open to the public in April. The part of the trail from International Speedway Boulevard to Orange Avenue is a little behind; he does not have a time schedule for that yet.

VIII. <u>Adjournment</u>

I. Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance

The meeting of the River to Sea Transportation Planning Organization (TPO) Bicycle/Pedestrian Advisory Committee (BPAC) was called to order at 2:00 p.m. by Chairperson Jason Aufdenberg. The roll was called and it was determined that a quorum was physically present. Due to the COVID-19 virus, the meeting was held in a hybrid format with 11

voting physically present; and with four voting and two non-voting members were virtually present. The meeting was held at the Volusia County Beach Safety Headquarters due to a flood in the TPO's conference room.

The Pledge of Allegiance was given.

Chairperson Aufdenberg stated the members participating virtually are doing so as a result of social distancing restrictions associated with COVID-19. Rulings from the Florida Attorney General require that the members physically present take a vote to allow virtual participation due to "extraordinary circumstances".

MOTION: A motion was made by Mr. Wendler to allow members attending virtually to participate and vote. The motion was seconded by Mr. Dodzik and carried unanimously.

II. <u>Public Comment/Participation</u>

There were no public comments.

III. Action Items

A. <u>Review and Approval of January 12, 2022 BPAC Meeting Minutes</u>

Chairperson Aufdenberg referred to his comment under "Member Comments" regarding the new Daytona Beach Riverfront Esplanade and that he walked from Main Street to International Speedway Boulevard (ISB), not to New Smyrna Beach.

Mr. Daun referred to the three safety presentations given last month and that member comments were not reflected individually. He would like his comments regarding the three safety presentations included in the minutes and to bring them back next month for approval. He referred specifically to comments he made during FDOT D-5 Safety Director Loreen Bobo's presentation.

Ms. Nicoulin explained that the minutes have been scaled back at the direction of the Executive Committee; they are not supposed to be verbatim but reflect actions taken and what was presented. She noted that all meetings are recorded and the recordings are available upon request. She asked if there is a particular comment Mr. Daun would like included.

Mr. Daun replied yes; Ms. Bobo mentioned a program that communities could apply to for safety funding. There were several questions asked and comments made during her presentation that the local communities should know about. He is requesting those specific safety comments be reflected as we have the highest bicycle/pedestrian fatalities in the country. In the future he will request his comments be reflected if he feels they are important.

Ms. Nicoulin stated it is not the TPO's intent to omit information. If it is the BPAC's request, staff will go back and add those comments to the minutes.

MOTION: A motion was made by Mr. Daun to postpone approval of the January 12, 2022 BPAC meeting minutes to the March 9, 2022 BPAC meeting and to add comments made regarding the safety presentations. The motion was seconded by Mr. Oebbecke and carried unanimously.

Chairperson Aufdenberg asked if the audio recording could be posted to the website.

Ms. Nicoulin replied it is a very large file so a link has to be created and posted to the file transfer site; there is a limit on what the file transfer site can hold and for how long. It is not a storage site.

Mr. Daun commented that since the Executive Committee made the decision to scale back the minutes, he would like this committee to request the audio file be made available to the public.

Ms. Nicoulin replied that there is an option on the website to request the audio as well as contact information for Ms. Blankenship.

Mr. Daun asked if that could be added to the minutes; that a complete audio file is available by request online.

Ms. Nicoulin replied yes, that can be added to the minutes going forward.

B. <u>Review and Recommend Approval of Resolution 2022-## Adopting the R2CTPO 2022 Safety Performance</u> <u>Targets</u>

Ms. Nicoulin stated the updated safety data and methodology used to develop the 2022 Safety Performance Targets were presented last month. The included draft resolution and Exhibit A reflect the targets based on the updated data. Two targets are being reset as the new data set was lower; serious injuries and the serious injury rate. The other three targets reflect a 2% annual reduction.

Ms. Belin commented that it seems wrong to have a target with so many fatalities; the target should always be zero. She referred to FDOT's Vision Zero campaign and the television ads she has seen.

Ms. Nicoulin replied the goal is zero; however, the TPO has to adopt current year targets. The TPO fully supports FDOT's target but the challenge is how to get there. The target is set based on a five-year rolling average. She explained that the TPO is only one aspect; there must also be law enforcement collaboration and education. She reiterated that the TPO fully supports FDOT's Vision Zero but has to set a realistic calendar year target for the TPO.

Discussion continued regarding the methodology and the targets.

Mr. Daun referred to the handout and asked for clarification on Task 3.01, Bicycle/Pedestrian Planning and Implementation.

Ms. Nicoulin explained the handout is for the Unified Planning Work Program (UPWP) presentation and discussion. The UPWP is the TPO's work plan which outlines the activities and deliverables; there are programs included that are directly related to safety, performance measures and how to drive the data down.

Mr. Wendler asked if Volusia County and/or the cities have adopted a Vision Zero plan.

Ms. Nicoulin replied that MPOs and FDOT are required by law to adopt safety targets; local governments can also adopt plans. FDOT sets a statewide target and each MPO is required to establish a target as well.

Discussion continued regarding the safety targets.

Mr. Daun commented it is his understanding that Vision Zero provides funding to local communities to help reduce the number of fatalities which is why he wanted his comments added to the January 12, 2022 minutes; he had also asked if the local communities had adopted Vision Zero but did not get an answer from Volusia County. He does not know of any municipality in our county that has applied for Zero One funding; he would like to make awareness of this funding become part of our service to the municipalities since we have such horrific numbers and no one seems to be mitigating that.

Ms. Gillis commented that it would be up to the city to apply for this funding.

Mr. Daun replied that they do not seem to be aware of it.

Ms. Gillis stated that we cannot assume that the municipalities are unaware of this funding just because they have not applied for it.

Mr. Harris stated the TPO encourages all committee members to take the information gained in these meetings back to their local governments.

MOTION: A motion was made by Mr. Storke to recommend approval of Resolution 2022-## adopting the R2CTPO 2022 Safety Performance Targets. The motion was seconded by Mr. Lodge and carried unanimously.

C. <u>Review and Recommend Approval of Resolution 2022-## Adopting the R2CTPO 2022 Transit Safety</u> <u>Performance Targets</u>

Mr. Harris stated a presentation was given last month on the Transit Safety Performance Targets; specifically, the Public Transportation Agency Safety Plan (PTASP) and the Transit Asset Management (TAM) Plan for the transit agencies in our planning area which are Votran, SunRail, and Flagler County Public Transportation. Included in the agenda are the resolution, Exhibit A which are the PTASP targets for Volusia County, and Exhibit B which are the TAM targets for Volusia and Flagler Counties.

Members discussed the transit safety targets and the data from Exhibits A and B. They also discussed equipment and their useful life benchmark.

MOTION: A motion was made by Mr. Storke to recommend approval of Resolution 2022-## adopting the R2CTPO 2022 Transit Safety Performance Targets. The motion was seconded by Ms. Belin and carried unanimously.

D. Appointment/Reappointment of 2022 BPAC Project Review Subcommittee Members

Mr. Harris stated there are currently seven members on the BPAC Project Review Subcommittee and all are eligible for reappointment. Also, if other members are interested, they can be appointed to the subcommittee.

Mr. Lodge volunteered and Mr. Aufdenberg, Mr. Wendler, Ms. Belin and Mr. Walters requested to be reappointed. Mr. McCallister declined reappointment.

Mr. Lodge asked how often the subcommittee will meet.

Chairperson Aufdenberg replied it is usually once or twice for a couple of hours.

Mr. Harris stated the Priority Process Schedule has the BPAC Project Review Subcommittee and TIP Subcommittee meeting sometime between March 14, 2022 and April 8, 2022. He will coordinate with the subcommittee members for a date and time. We do not yet know how many project applications will be received because the application period is still open; there will be one or possibly two subcommittee meetings.

MOTION: A motion was made by Mr. Storke to appoint Mr. Lodge and reappoint Mr. Aufdenberg, Ms. Belin, Mr. Mostert, Mr. Walters, Mr. Wendler to the 2022 BPAC Project Review Subcommittee and reappoint Ms. Burgess-Hall as an alternate. The motion was seconded by Mr. Coletti and carried unanimously.

E. <u>Appointment/Reappointment of 2022 Transportation Improvement Program (TIP) Subcommittee Members</u>

Ms. Nicoulin explained that the BPAC Project Review Subcommittee reviews the bicycle/pedestrian project applications that come in through the annual Call for Projects and the TIP Subcommittee reviews the traffic operations/safety and planning studies project applications. The subcommittees typically meet once and sometimes twice to review and rank the project applications. She will coordinate with the subcommittee members for a date and time.

MOTION: A motion was made by Mr. Daun to reappoint Mr. Eik, Mr. Storke and Ms. Belin to the 2022 Transportation Improvement Program (TIP) Subcommittee. The motion was seconded by Mr. Leal and carried unanimously.

IV. <u>Presentation and Discussion Items</u>

A. Presentation and Discussion of the Draft FY 2022/23 and 2023/24 Unified Planning Work Program (UPWP)

(Handout)

Ms. Nicoulin explained the Unified Planning Work Program (UPWP) is a two-year work plan that includes TPO activities as well as the budget for those activities and tasks. We are currently in the second year of the current UPWP and the new UPWP will become effective July 1, 2022. She noted that due to staffing shortages, there are a number of deliverables in the current UPWP that we were unable to complete this year and some of those will be carried over into the new UPWP. She explained that the TPO is currently undergoing a search for a new Executive Director and hopes to have that position filled by the end of this fiscal year; developing a new work plan without that leadership input has been a challenge so there could be a potential UPWP amendment within the first six months of the new UPWP. She reviewed the draft tables of tasks, activities and deliverables for the new UPWP covering fiscal years 2022/23 and 2023/24.

Members discussed the various tasks and activities for the draft FY 2022/23 and 2023/24 UPWP including those that are related to bicycle/pedestrian safety and mitigation. It was explained the TPO coordinates with the local agencies or FDOT's Safety Office, whoever has jurisdiction of a roadway, on hot spot areas and how to address safety concerns. Members discussed crash data and it was explained that the TPO is required to use certified data for studies which is always a year old. Recent general information is available through Signal Four Analytics; details may only be available with a login but she will look into it. Members also discussed updates to the Congestion Management Plan (CMP) and Transportation Impact Analysis (TIA).

Ms. Nicoulin continued to review the tasks and activities within the new UPWP. Mr. Harris reviewed the activities and deliverables within Task 3.01, Bicycle/Pedestrian Planning and Implementation including school safety studies, the bicycle/pedestrian count program and a Bicycle/Pedestrian Safety Action Plan. He asked for input regarding an update to the 2019 Bicycle Suitability Map; members discussed the map and the fact there are new bike paths, sidewalks and trails. Members discussed how to correct the errors in the current map and ways to make it current.

Mr. Daun commented he would prefer supporting Volusia County with their Master Plan which would include the municipalities for the existing system of what we have. We could take their data and look at the suitability of the system with what is anticipated and what is completed. There is a lot that needs to be added but the county is already doing it; he suggested letting the county gather the data and revisit this in a year.

Mr. Harris replied that the urbanized area of Flagler County would have to be looked at as well.

Members discussed the data sources for the map and that there are more opportunities for data sharing now.

Mr. Harris finished reviewing the bicycle/pedestrian and transit tasks and activities. Ms. Nicoulin commented that the budget for the new UPWP is currently being developed. The draft UPWP will be submitted to FDOT and the Federal Highway Administration (FHWA) for review and comment; there will also be an open public comment period. The final draft of the new UPWP will be presented to the BPAC in April or May for a recommendation of approval.

V. <u>Staff Comments</u>

Mr. Harris announced Mr. Patrick McCallister has been appointed as the Lake Helen BPAC representative; he previously represented Volusia County D-1. Ms. Maggie Ardito has been appointed as the Volusia County D-1 BPAC representative.

Ms. Nicoulin announced that the TPO received a request from FDOT on Friday to amend the Connect 2045 Long Range Transportation Plan (LRTP); the amendment is to support money received as part of the stimulus package. The TPO's planning area received \$90 million in stimulus funding and we were able to fund a number of phases of the interchange projects along I-95; the interchanges at LPGA Boulevard and US 1. These projects are currently in the 2045 LRTP but this funding has accelerated the project phases so the LRTP has to be amended to reflect the timing of the funding and bring the document into consistency with the Transportation Improvement Program (TIP). The design phases for both projects have been brought into the current fiscal year and the LPGA Boulevard project limits have been extended to US 92. There will be a 30-day public comment period that will open later this month. This amendment will be back as an action item next month.

Ms. Nicoulin provided an update on the Executive Director search and announced the Executive Director Search Committee (EDSC) met the beginning of January and decided to re-open the application period through January 31, 2022. The TPO hopes to have a candidate to recommend to the TPO Board at the April board meeting and have a new Executive Director on board by the end of the fiscal year.

Ms. Nicoulin explained the meeting today was being held at the Volusia County Beach Safety Headquarters due to a flood in the TPO's conference room caused by a failed water heater in an adjoining office. She thanked members for being able to meet in this alternate location today.

Mr. Dodzik asked how many Executive Director applications were received.

Ms. Nicoulin replied 26 applications were received and the recruiter narrowed those down to 18 qualified candidates that the EDSC will review and discuss at the February 17, 2022 EDSC meeting. They will narrow those down to 8 to 12 candidates for the next phase of the recruitment process.

VII. BPAC Member Comments

Mr. Daun announced there was a bicycle/pedestrian fatality recently on Oakridge Boulevard at the newly constructed bike lane at Halifax Avenue. He does not know the details; the zippers are not yet in place and the bike lane is not painted green as it was shown in the rendering. He attended the Mason Avenue Corridor Improvement public meeting; the TPO conducted a safety study on Mason Avenue. The safety study and safety issues were discussed but they are only budgeting for resurfacing and not including any right-of-way or medians; nor are they including any safety mitigation that was discussed as part of this project. This is not acceptable since there are so many deaths on that road. FDOT needs to know it is not okay and they need to get funding for right-of-way to install landscaped medians, proper turn lanes and wider sidewalks.

Mr. Lodge thanked the TPO staff for all they do; they have a large bucket list with a small staff to tackle it. It is the BPAC members responsibility to express the needs to their community.

Chairperson Aufdenberg stated he also attended the Mason Avenue public meeting and had a more positive experience; they are installing sidewalks and will fill the sidewalk gaps. He felt they listened to his concerns about the present conditions of the road and why he would not ride on it. There are areas that could benefit from pedestrian hybrid beacons; there are a lot of residents in that area that do not drive.

Mr. McCallister thanked TPO staff for working with him to get him appointed as the Lake Helen representative.

Ms. Ardito thanked the members for a welcoming her and she looks forward to working with the BPAC.

Mr. Storke asked if the TPO will have a booth at the Spring to Springs Family Fun Ride and Trail Celebration on March 20, 2022.

Ms. Ardito replied that they are just getting the planning in place and she will reach out to Ms. Blankenship about the TPO's participation.

Ms. Nicoulin noted that the challenge will be if staff is available; the TPO typically schedules events further out so she cannot commit at this time.

VIII. Adjournment

The BPAC meeting adjourned at 4:08 p.m.

WHEREAS, 23 C.F.R. 450.306 establishes the planning factors that must be considered by each metropolitan planning organization in the development of a long range plan; and

WHEREAS, the River to Sea TPO Board is seeking to amend the Connect 2045 LRTP to reflect updated funding for I-95 Interchanges at LPGA Boulevard and US 1; and

WHEREAS, the River to Sea TPO has solicited public comment on the proposed amendment during a public review period meeting the required 30 days as prescribed in Chapter 8 of the adopted plan; and

At last month's meeting TPO staff reviewed the draft tasks for consideration.

TPO staff will provide an update of the recommended tasks and activities as well as the funding allocations to be included in the draft FY 2022/23 to FY 2023/24 UPWP.

B. PRESENTATION AND DISCUSSION OF UPDATES TO THE RIVER TO SEA TPO TITLE VI AND LIMITED ENGLISH PROFICIENCY (LEP) PLANS

BACKGROUND INFORMATION:

The purpose of the River to Sea TPO's Title VI Plan is to establish and implement procedures that comply with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, the Americans with Disabilities Act of 1990 (ADA), as well as other related federal and state statutes and regulations. These procedures are necessary to conform to Federal Transit Administration (FTA) and Federal Highway Administration (FHWA) regulations, as well to Florida Department of Transportation (FDOT) guidelines. The TPO's Title VI Plan defines what Title VI is, includes a written process on how to file a Title VI complaint, and describes the complaint investigation process. Title VI states "no person in the United States shall, on the grounds of race, color or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance."

The Limited English Proficiency (LEP) Plan addresses the TPO's responsibilities as a recipient of federal financial assistance as they relate to the needs of individuals with limited English language skills. The goal of the River to Sea TPO Limited English Proficiency (LEP) Plan is to ensure that the TPO recognizes the needs of limited English proficient (LEP) members of the community, implements a plan to communicate effectively and ensures reasonable access to our processes, information and decision-making.

The River to Sea TPO's Title VI and Limited English Proficiency Plans have been updated to reflect updated Federal Highway Administration requirements. In addition, the demographic and socioeconomic data for the TPO's metropolitan planning area has been updated in the LEP Plan. Both the Title VI and LEP plans are provided for your review and comment. A 30-day public comment period is required prior to adoption of changes to the documents.



Public Comment Requested on Connect 2045



The River to Sea Transportation Planning Organization (TPO) is seeking public comment on a proposed amendment to Connect 2045, the TPO's Long Range Transportation Plan (LRTP). The TPO is seeking to amend Connect 2045 for the following two projects:

- I-95 Interchange at US 1

 Reflect updated project funding for the design (PE) phase and right-of-way (ROW) phase for the project by advancing the PE funding from years 2031-2035 to 2021-2025 and adding ROW funding to years 2026 –2030.
- I-95 Interchange at LPGA Blvd— Reflect updated project funding for the design (PE) phase and right-ofway (ROW) phase for the project by updating PE cost estimates and advancing the PE funding from years 2031-2035 to 2021-2025 and adding ROW funding to years 2026 –2030. Additionally, this amendment extends the limits of the project to include LPGA Blvd from US 92 to Williamson Blvd.
