- General consensus of the TCC members was to place the money where it is most appropriate in the TPO planning area; directed TPO staff to request a formal response from FHWA citing why the projects are maintenance and not operational improvements
- Received TPO staff update on the status of the supporting resolutions for the Reapportionment Plan received by the TPO to-date
