1. Call to Order / Roll Call / Determination of Quorum/Pledge of Allegiance

The Volusia-Flagler Transportation Planning Organization (TPO) Board meeting was called to order at 9:00 a.m. by TPO Chairperson Sander. The roll was called, and it was determined a quorum was physically present. The meeting was held in a hybrid format with twelve voting members and one non-voting member physically present, and three voting members and one non-voting member virtually present.

Ms. Pruneau announced that Commissioner Werning, Oak Hill, would be the voting member for the Small City Alliance.

The Pledge of Allegiance was given.

MOTION: *A motion was made by Council Member Foley to allow members attending virtually to participate and vote. The motion was seconded by Mayor Chasez and carried unanimously.*

MOTION: *A motion was made by Vice Mayor Martin to accept the addition of two Action Items to the agenda items to the agenda. The motion was seconded by Council Member Foley and carried unanimously.*

MOTION: *A motion was made by Vice Mayor Martin to approve the Consent Agenda. The motion was seconded by Council Member Foley and carried unanimously.*

4. Action Items

- A. Review and Approval of Resolution 2025-04 amending the FY 2024/25 to FY 2028/29 Transportation Improvement Program (TIP) (Roll Call Vote)

MOTION: *A motion was made by Council Member Johansson to approve Resolution 2025-04 amending the FY 2024/25 to FY 2028/29 Transportation Improvement Program (TIP). The motion was seconded by Council Member Foley.*

Ms. Nicoulin stated that a formal amendment to the TIP is required to move four transit projects forward in Volusia and Flagler Counties. She stated that the Federal Transit Administration is funding these projects and that it does not take funding away from any current projects.

The motion carried unanimously by roll call vote.

B. Review and Approval of the 2024 Annual FDOT/TPO Joint Certification

MOTION: *A motion was made by Council Vice Chair Reinhart to approve the 2024 Annual FDOT/TPO Joint Certification. The motion was seconded by Commissioner Cantu.*

Ms. Powell explained that each year FDOT works with the TPO to ensure all processes are carried out in accordance with the state and federal statutes. She remarked that in 2024, the TPO received a score of 100% and was given a low-risk rating.

Chairperson Sander remarked that this was noteworthy and the TPO has come a long way from a few years ago.

The motion carried unanimously.

C. Review and Approval of Resolution 2025-05 adopting the 2025 Adjusted Performance Measure Targets for PM2 (Bridge & Pavement) and PM3 (System Performance)

MOTION: *A motion was made by Council Vice Chair Reinhart to approve Resolution 2025-05 adopting the 2025 adjusted performance measure targets for PM2 (Bridge & Pavement) and PM3 (System Performance). The motion was seconded by Commissioner Cantu.*

Ms. Nicoulin stated that these targets are set every four years; they were last adopted by the TPO in 2023 and mirrored those that FDOT set. Midway through last year, FDOT adjusted its targets; following that, the TPO has 180 days to adjust its targets to match. As the TPO supports the state targets for performance measures, she recommended the adoption of their adjusted targets.

Council Member Foley asked about penalties for failing to adopt these adjustments, of which there are none to the TPO. By adopting these measures, the TPO is agreeing to program projects to help meet these targets.

The motion carried unanimously.

D. Review and Approval of an expenditure not to exceed \$40,000 for a Change Order Associated with the Build-Out of the New TPO Office Space

Ms. Nicoulin reviewed that there had been a tentative allowance for the construction of the new TPO office space of \$244,000. However, due to cost increases, the estimate rose to just over \$80,000 above that allowance. She stated she worked with the contractor to cut costs, bringing that estimate down to around \$59,000 over the tentative budget, which the landlord agreed to cover, effectively eliminating the overage. She noted that there are three different carpets in the new office space and all should be replaced with one carpet. The cost of replacing the carpet was estimated at \$40,000.

Members discussed whether the \$40,000 expenditure would be enough to cover the estimate for the flooring. Ms. Nicoulin stated that, due to receiving line-item credits, the estimate for the flooring was reduced to around \$32,000.

MOTION: *A motion was made by Commissioner Cantu to approve the expenditure not to exceed \$40,000 for a change order associated with the build-out of the new TPO office space. The motion was seconded by Council Vice Chair Reinhart and carried unanimously.*

5. Presentations, Status Reports, and Discussion Items

A. Presentation and Discussion of the Development of the Volusia-Flagler 2050 Long Range Transportation Plan (LRTP)

Mr. Jim Wood, Kimley-Horn, gave a PowerPoint presentation discussing the preliminary needs and evaluation criteria for the 2050 Long Range Transportation Plan (LRTP). He mentioned pertinent updates and upcoming

activities including Open Houses workshops; three taking place on April 21st in Port Orange, April 28th in Palm Coast, and April 30th in DeLand. Population forecasts for Volusia and Flagler Counties and anticipated key milestones were also discussed.

Mayor Chasez stated the importance of including improvements relating to safety and congestion on Interstate 4 from Sanford east along the St. John's River Bridge.

Members discussed workshop attendance; Mr. Wood encouraged the use of social media to garner more attendance and noted the importance of having three different meeting locations for public accessibility. Chairperson Sander implored all council members to share information regarding the workshops on social media.

B. FDOT Report

Ms. Powell reviewed the FDOT Report and announced an inaugural transportation industry hiring event on April 30th at Osceola Heritage Park, stating that she would share the flyer with the TPO to relay the information, and the FDOT's Central Florida Safety Summit taking place at the Daytona International Speedway on May 9th. She also noted that there was a reduction of 15% in fatalities this year in District 5, equating to 110 lives saved.

6. Executive Director's Report

Ms. Nicoulin mentioned that she is closely monitoring two bills; Senate Bill 462 and House Bill 567, which were recently filed that would eliminate the MPOAC and affect MPOs across the state. She discussed the MPOAC weekend training institute on May 16th and 17th in Tampa, stating that the TPO has budgeted for three board members to attend; she encouraged members to reach out to Ms. Pruneau if they are interested in attending. She notified members of upcoming community Vision Zero Action Plan workshops: April 3rd in Daytona Beach, and April 17th in Palm Coast. She reminded members that the September TPO Board meeting date was changed from the 24th to the 17th to stay within compliance with the LRTP.

There were no TPO Board member comments.

8. Volusia-Flagler TPO Chairperson Comments

Chairperson Sander encouraged TPO Board members to assign alternates for any committee vacancies that were listed in the attendance records.







Project Evaluation Criteria

The application of technical criteria is an important way to measure and evaluate transportation projects relative to the *Volusia-Flagler 2050* goals and objectives. These measures also provide us with a strategy that helps translate a variety of project attributes into an overall score and priority ranking. By identifying critical factors such as safety, disadvantaged populations, freight, tourism, and resource protection, we're able to quantify and compare the benefits of various transportation projects and inform project selection. These criteria are an integral component of the planning process that provide meaningful direction.

Applicable roadway projects from the Needs Assessment will be identified and evaluated based upon criteria to inform prioritization and selection of projects for inclusion in the Cost Feasible Plan. Because the focus of available revenues within the Cost Feasible Plan will be on major non-SIS corridors, this set of projects will be the primary emphasis for technical criteria scoring. Any evaluation of SIS and local projects not expected to receive state or federal funding is for informational purposes only.

The selection of project evaluation categories and criteria in **Table 1** was guided by the policy direction of the approved *Volusia-Flagler 2050* Goals and Objectives and with consideration of planning factors and transportation performance measures as required under 23 Code of Federal Regulations 450.306. Additionally, certain criteria address other state and/or federal requirements. Technical criteria scoring will be just one factor considered when prioritizing and selecting projects. Other considerations will influence project selection decisions such as the position of projects in *Connect 2045*, the 2024 List of Priority Projects, and the collaboration and input of residents and elected officials in ensuring that the plan of projects best represents the collective priorities of the community.

The project evaluation criteria in **Table 1** are presented to the TPO Committees and Board for review and approval. The *Volusia-Flagler 2050 Goals Implemented* that are referenced in the second column refer to the following:

Goal 1 – Develop and maintain a balanced and efficient multimodal transportation system

Goal 2 – Support the economic development and growth of the TPO area and region

Goal 3 – Enhance and expand transportation connectivity and choice for all users





Preliminary Needs Assessment (DRAFT – 4/15/2025)

The Preliminary Needs Assessment maps and tables represent a tentative list of roadway projects¹ to consider for prioritization and potential inclusion in the *Volusia-Flagler 2050* Cost Feasible Plan. Each of the roadway projects is included for one or more of the following reasons:

- Identified in an existing cost feasible plan such as the *Connect 2045* Long Range Transportation Plan (LRTP) and/or the FDOT Strategic Intermodal System (SIS) Long Range Cost Feasible Plan
- Identified in the Volusia-Flagler TPO 2024 List of Prioritized Projects
- Identified as local needs
- Identified as a potential need based upon forecasted peak hour traffic demand from the Central Florida Regional Planning Model v7 which is based upon socioeconomic and other data

Taken together, the three separate categories delineated in the maps (SIS, State Highway (Non-SIS), and Non-State Major Roadways) provide a comprehensive view of roadway needs. However, each category differs as follows:

- **Strategic Intermodal System (SIS) [Map A1]**
The SIS is Florida's high priority network of transportation facilities. SIS projects are identified at the state level by FDOT with input from MPOs and local governments. Projects identified on this map are included in the existing SIS Long Range Cost Feasible Plan, SIS 5-year Plans, the *Connect 2045* LRTP Cost Feasible Plan, or are related to SIS projects. In *Volusia-Flagler 2050*, these projects will be included on a separate SIS cost feasible project list. While the LRTP development process may lead to suggested revisions to some of these projects, changes to the SIS plans are determined outside of this process.
- **State Highway System (Non-SIS) [Map A2]**
The State Highway (Non-SIS) needs are located on major non-SIS corridors that are on the State Highway System. These projects could be funded through federal (TMA) funds and State Highway System (Non-SIS) funds as defined in the *Volusia-Flagler 2050* Revenue Forecast. Specific TMA (SU) set-asides are defined in [VFTPO Resolution 2024-20](#).
- **Non-State Major Roadways [Map A3]**
These needs are located on roadways that are not on the SIS or State Highway Systems (i.e., roads owned by counties and municipalities). These projects could be funded

through the Other Roads (Non-SIS, Non-SHS) funds as defined in the *Volusia-Flagler 2050 Revenue Forecast* or expected to be funded through local revenue sources.

The projects in the tables are not listed in priority order. Numbering is provided to identify projects on the corresponding map. Ranking will take place after prioritization categories and criteria are finalized.

Where noted in the table, project phase acronyms refer to the following:

- PD&E – Project Development & Environment
- PE – Design (Preliminary Engineering)
- ROW – Right of Way
- CST – Construction



SUMMARY BACKGROUND:

The Volusia-Flagler TPO's Vision Zero Action Plan will create a comprehensive safety action plan for Volusia and Flagler Counties, in coordination with each municipality. A Vision Zero Action Plan includes:

- **High Injury Network:** analyzing data to identify places on the transportation system with the highest risk for fatal and serious injury crashes so that we can focus on our most important problem areas.
- **Equity Component:** identifying and prioritizing efforts in disadvantaged communities that are disproportionately affected by traffic crashes.
- **List of Priority Streets and Intersections:** producing a list of feasible projects that have the most safety impact for the region.
- **Educational and Enhancement Programs:** identifying key behavioral changes needed to reduce crashes and methods for encouraging those changes.
- **Sustained Effort:** establishing a defined process and identifying an organization responsible for carrying out, updating, and monitoring progress.

Representatives from VHB, the TPO's consultant for the Vision Zero Action Plan, will present the background of Vision Zero, Safe System Approach, Safety Analysis and the High Injury Network, Equity Analysis, Policy and Process Review, and the next steps for the plan.











MOTORCYCLE CRASHES – HELMET USE




CRASHES BY CRASH TYPE








CRASHES BY LOCATION


Scoring and Identification:

- ∞ Used unique County averages
- ∞ Census tracts scored based on meeting/exceeding county-specific averages.
- ∞ Tracts meeting/exceeding four or more criteria identified as transportation equity focus areas.



EQUITY ANALYSIS CONCLUSION AND RECOMMENDATIONS

- ∞ Areas with high concentrations of census tracts that meet 4 or more of the equity criteria are strongly correlated with the HIN.
- ∞ There are variations of denser “equity areas” that meet 6 or 7 of the equity criteria – eastern Volusia County, western Volusia County, and the northeast portion of Flagler County.
- ∞ The variations among equity areas can be used to help prioritize the HIN segments in the TPO region.

Update on the 2025 Annual Call for Projects

SUMMARY BACKGROUND:

The Volusia-Flagler TPO annually submits to the Florida Department of Transportation a prioritized list of projects for implementation within the TPO Planning Area. These priorities are used by FDOT to program State and Federal transportation funds. Programming commitments made by FDOT are included in its Five-Year Work Program and the TPO's Transportation Improvement Program (TIP).

Projects on the Priority List come from a variety of sources including the Long Range Transportation Plan (which populates the Strategic Intermodal System (SIS) Roadway list and the Regionally Significant Non-SIS Roadway list); the SUN Trail Program (which populates the SUN Trail list); regional transit agencies (which populate the Transit Projects List), and local governments (which populate the lists for Traffic Operations Projects, Bicycle/Pedestrian Projects, Transportation Planning Studies, and Transportation Regional Incentive Program (TRIP) Eligible Projects).

The priority list is updated annually by the TPO, and this process begins with the Call for Projects to solicit project applications from local governments in the traffic operations, bicycle/pedestrian, and transportation planning study categories. These project applications are ranked based on an established set of criteria by a subcommittee made up of members from the TPO advisory committees. From these rankings, the TPO develops a draft list of project priorities that it makes available for public review and comment. The List of Prioritized Projects is formally reviewed by the TPO advisory committees and adopted by the TPO Board during their June meeting.

TPO staff will lead a discussion on the List of Priority Projects and the process used to annually update the list as well as provide a summary of the project applications received during this year's call for projects.

Road & Bridge Program

- Walnut Avenue Paving Project – 100% Design Complete. Plans Finalization and permitting/easement acquisition process to conclude in May 2025.
- Westmayer Place Paving Project – 100% Design Complete. Plans finalization and permitting to conclude in June 2025.
- Canal Avenue (CR 302) from Water Oak Road to Forest Park – Design to conclude in April 2025.
- Jungle Hut Road from A1A to beach access – Design to commence in second quarter 2025.
- Forest Park Street from CR 90 to SR 100 – Design to commence in second quarter 2025.
- Flagler Central Commerce Parkway Connector Project – Construction completion in July 2025.
- Old Haw Creek Road – Construction underway. Anticipated completion by August 2025.
- CR 205 Resurfacing Project – Required design update in progress in preparation of construction contractor procurement. Construction anticipated to commence by second quarter 2025.
