### I. Call to Order / Roll Call / Determination of Quorum

The meeting of the River to Sea Transportation Planning Organization (TPO) Board was called to order at 9:00 a.m. by TPO Chairperson Chris Cloudman. The roll was called, and it was determined a quorum was physically present. The meeting was held in a hybrid format with 16 voting and three non-voting members physically present; and with one non-voting member attending remotely.

Ms. Stewart announced Vice Mayor Smith, Ponce Inlet, as the Small City Alliance's voting member.

### MOTION: A motion was made by Mayor Partington to allow TPO Board members attending remotely to participate and vote. The motion was seconded by Vice Mayor O'Connor and carried unanimously.

MOTION: A motion was made by Mayor Chasez to approve the Consent Agenda. The motion was seconded by Commissioner Cantu and carried unanimously.

#### V. <u>Presentations and Discussion Items</u>

#### A. Presentation and Discussion of the Functional Classification Update and Review Process

Ms. Alice Giuliani, FDOT, gave a PowerPoint presentation on the update and process of the Functional Classification review. An overview was previously provided in August of 2022. Since then, FDOT has conducted

a comprehensive review and update to address changes in the roadway system as well as reevaluating the roadway function districtwide; the result is the proposed Functional Classification data layer. They have completed the draft Functional Classification online application and finalized it this month. FDOT will complete the local agency review process by April 28, 2023, and will present the draft Volusia and Flagler Counties Functional Classification Maps to the advisory committees and TPO Board in May followed by a request for adoption in June.

Mr. Jason Learned, FDOT, continued the presentation; the FDOT Decennial Function Classification Review website was created to explain what the Functional Classification Review is, why they are doing it, and the timeline. He reviewed the guidelines for input and comments; maps are individual by county and QR codes were created for the map links. He gave a demonstration of how to provide input and submit comments. He referred to the guidelines provided; FDOT is looking to see if the new roads in Volusia and Flagler Counties and the existing roads' functional classifications are still appropriate or if the changes made are accurate. He explained that this is a data-driven process and FDOT reviews traffic counts, speed limits, etc., to determine how a roadway is functioning as well as destinations they connect to. FDOT is looking for local agencies to provide them with comments on how a roadway is functioning.

Ms. Nicoulin added that urban boundaries and functional classifications are updated every ten years following the US Census. She asked Ms. Giuliani to provide some additional background information on the process and why it is done.

Ms. Giuliani explained that the Functional Classifications for all roadways in each FDOT district are reevaluated following the US Census every ten years; the public is allowed the opportunity to review the changes and provide comments. Urban boundaries are adjusted by the Census Bureau and can be refined, if desired, by the Federal Highway Administration (FHWA) and FDOT. The method is to assign public roadways into classifications according to the character of service they provide in relation to the total roadway network. She explained the purpose of Functional Classification may be considered in prioritization processes, and roadway design along with context classification, as it defines data collected for performance management and determines funding eligibility from sources such as FEMA emergency response funding. She explained what an urban boundary is and that the urban boundary update process will begin in late summer. She also explained how the federal-aid highway system funding flows; local roads do not receive federal-aid funding.

Chairperson Cloudman stated that this information is helpful and shows why it is important; new neighborhoods, new roads, and capacity on existing roads have been added prior to the Census so reevaluating the classification makes sense so that local agencies know to apply for the right funding source.

Ms. Nicoulin further explained that two updates are currently ongoing: one to the Functional Classification and the other to the urban boundaries. They are separate but conducted at the same time. The web app Mr. Learned explained earlier was created for comments to be provided that are associated with the update to the Functional Classification which looks at the classification of roadways based on if they are arterials, major collectors, minor collectors, or local roads. This determines which roadways are eligible for federal funding. There are new roads in our planning area that have been constructed since the last Census was undertaken and they do not have a Functional Classification assigned to them. This presentation was provided to the TCC yesterday and FDOT is asking them to provide comments specific to the road network within their jurisdiction to ensure the preliminary Functional Classification assigned by FDOT is appropriate. The update to the urban boundary will begin this summer after the Functional Classification is adopted by the TPO Board; it is based on the last US Census so there will be updates to the urban area boundary. The TPO will look at an expansion of the planning area in Flagler County; currently, the TPO's planning area covers all of Volusia County but only the urbanized area of Flagler County. The TPO has asked the local municipalities to provide comments regarding the update to the Functional Classification by April 28, 2023, so FDOT has time to prepare the draft map to present to the advisory committees and TPO Board in May followed by adoption in June. FDOT is available to meet with the local agencies if needed.

Ms. Giuliani noted that another portion of the app shown earlier will be available next week that will show the proposed update to the urban boundaries.

Mr. Learned stated a question was received from the TCC that they would like to see the actual changes to the Functional Classification in their cities with data to help them determine their comments; it will be map-based and include data tables. Each city will be able to see its city limits, its roads, and changes in mileage. There are 91 cities within FDOT District 5; thirty-nine of those have no changes. Once feedback from the local cities is received, FDOT will refine the dashboard in the app.

Commissioner McCool commented that Deltona is the largest city within Volusia County and has several major roadway projects; she would like a one-on-one with either FDOT or TPO staff to understand the Functional Classification and how to raise awareness in the communities on how they benefit from this. She wants to know how to motivate her residents to participate in this; she asked how the board members can go back to their cities and raise awareness. The TPO Board members work collectively but they need to know how to stress the importance of this in their communities and how to stretch the funding available.

Ms. Nicoulin explained the review of the Functional Classification is a technical review that falls to the cities' technical staff; the review looks at the data of the roadway; traffic counts, speed limits, etc., in order to assign the Functional Classification. More detail on the app was provided yesterday to the TCC as they are the ones reviewing the Functional Classification in their cities.

#### B. Presentation and Discussion of Volusia County Trails Master Plan

### (Handout)

Mr. Tim Baylie, Director of Volusia County Parks, Recreation, and Culture Division, gave a PowerPoint presentation on the Volusia County Trails Master Plan. The county is seeking public input on the draft Trails Master Plan. He provided background information on the trail master plan's development including the history of trails in Volusia County and reviewed the existing and proposed trails within Volusia County including the St. Johns River to Sea Loop Trail and Coast-to-Coast Trail as well as the amenities that will be added. SUN Trail funding is the primary funding source for all trail development within Volusia County. He reviewed the planned expenses for the Environment, Culture, History, and Outdoor Recreation (ECHO) funds in the near term and the design guidelines used for trail segments. Each segment meets FDOT design and safety standards. He explained that municipalities that receive SUN Trail funding must commit to maintaining the trail once developed. He reviewed the marketing and branding of the trails and the information that is available on the trail signage as well as the Volusia County Parks and Trails mobile app, how it works, and what information is available on it. He noted that the Trails Welcome Center is located at DeBary Hall which is where several trails intersect and an interactive panel map is located which includes trip navigation, lodging and restaurant information, and trail maps; the map is also available on the county's website. He referred to the handout provided which has the QR codes for the draft Trails Master Plan, a trails survey, and the Trails Master Plan Interactive Map. He encouraged members to complete the trails survey. All the information received will be compiled and presented to the Volusia County Council for adoption.

Chairperson Cloudman commented he reviewed the draft master plan online and noted that it is very detailed; he encouraged board members to review it.

Mayor Chasez noted that the city of DeBary is very involved because the major trails connect in DeBary; they are building municipal trails in addition to the county trails. There is a bike repair station at the Welcome Center and another repair station along Highbanks Road that is part of the trail. They are good additions to have these repair stations since it is an extensive trail system.

Vice Mayor O'Connor referred to electric/pedal assist bicycles and that some parts of the trails have notices stating "no motors" allowed; he asked how that is being addressed.

Mr. Baylie replied there is a section in the draft trails master plan dedicated to electric bicycles; there are three classifications of electric bicycles that he reviewed. It is very difficult to police electric bicycles and to determine the classification; the Class 2 and 3 electric bicycles go very fast. He noted that safety is a big issue on the trails. There are also motorized skateboards that can go faster than 20 miles per hour as well as segways; there is a state law that allows segways on bike trails.

Members continued to discuss the presentation and the classification of electric bicycles; they are also an Americans with Disabilities Act (ADA) issue as they allow the disabled access to the trails. It was noted that trails can increase residential property values if the homes are within 1,000 feet of a trail; trails also bring in revenue to restaurants and other businesses.

#### C. Presentation and Discussion of TPO 101: Plans, Programs, and Member Responsibilities

Ms. Nicoulin gave a PowerPoint presentation on what the TPO does, and its plans and documents; the TPO is required to exist by federal and state law for any area over 50,000 in population and to identify and prioritize projects for how federal and state dollars are spent locally. Any urbanized area over 200,000 in population is considered a Transportation Management Area (TMA), which the River to Sea TPO is. The TMA designation comes with more responsibility and funding opportunities; it also requires more oversight and federal certification. She explained what each advisory committee does and the responsibilities of the committee members. The TPO provides a forum to discuss transportation local priorities, transportation funding, transportation improvements, and the use of federal and state funds. She reviewed the core documents that the TPO is required to produce and explained each of them; why they are required, the funding associated with them, how they are developed, and how each tie into FDOT's Work Program. She explained the TPO's List of Priority Projects (LOPP) and the Unified Planning Work Program (UPWP) which is the TPO's two-year work plan for deliverables and the budget associated with each task. The TPO has a strong online web presence which Ms. Pamela Blankenship manages. She reviewed upcoming activities which included updating required documents; federal certification; the implementation of the Safe Streets and Roads for All (SS4A) grant, developing the TPO's Strategic Action Plan; rebranding the TPO; and relocating the TPO offices to a permanent location. She encouraged members to share the TPO's information with their community and to support staff at events the TPO participates in.

Chairperson Cloudman stated the MPO Advisory Council (MPOAC) is the statewide organization that offers a training session each year; it is a multi-day training that goes into depth; each TPO can send two members to the MPOAC Institute.

Vice Mayor Politis commented that as a new TPO Board member, this presentation was very helpful. He asked whom to contact regarding the inconsistent crosswalks in his jurisdiction.

Ms. Nicoulin replied there are a number of ways to report the crosswalks; the FDOT Liaison to the TPO if it is on a state road; sometimes the TPO is not the correct contact, but we can provide a bridge to the right one.

Commissioner Dance thanked the TPO for its participation in the Flagler Community Traffic Safety Team; Volusia County also has one and it is a way to connect with different entities that can help.

Ms. Nicoulin noted there are three Community Traffic Safety Teams; one in Flagler County and two in Volusia County; an east and west team. The TPO participates on all three teams.

#### D. Presentation and Update on 2023 Annual Call for Projects

Chairperson Cloudman stated that each year, the TPO accepts applications for traffic operations and bicycle/pedestrian projects, as well as for planning studies. This year's Call for Projects ended on February 28, 2023.

Ms. Nicoulin explained that each year, the TPO asks local governments to submit project applications which then compete for funding; bicycle/pedestrian projects, traffic operations projects, and transportation planning studies. She reviewed the project applications received through this round of Call for Projects which closed on February 28, 2023; and explained that applications for feasibility studies and project implementation are accepted within each category. She announced the BPAC Project Review Subcommittee will be meeting today at 1:00 pm to review and rank the bicycle/pedestrian project applications; the TIP Subcommittee meeting has not yet been scheduled. The ranked and scored new projects will be merged into the current LOPP based on their ranking and be presented for review in May followed by adoption in June.

### E. FDOT Report

Ms. Rakinya Hinson, FDOT, stated the FDOT report provided in the agenda is current as of February 28, 2023; she referred members to <u>www.cflroads.com</u> for the most up-to-date project information. This website can be shared with the members' constituents as well. If anyone has specific questions regarding a project, she can gather the information and provide it to the TPO to distribute.

### VI. <u>Executive Director's Report</u>

Ms. Nicoulin noted that the TPO recently relocated temporarily to the Florida Tennis Center on LPGA Boulevard; there is not a large conference room which is why the TPO committee and board meetings are being held in the Airline Room at the Daytona Beach International Airport until further notice. She referred to the letter to the previous landlord; it acknowledges that the TPO moved out of the prior location before February 28, 2023, but that the move did not come without damage to the TPO. The letter identifies the monetary damages the TPO incurred due to the move and that the TPO will have to move again to a permanent location which will incur additional costs. An original cost estimate was submitted prior to the move to the landlord but once the move was completed, the true cost was submitted. It is her understanding that the landlord submitted the TPO's request as part of their insurance claim; she received a phone call yesterday that they are in negotiations with the insurance company; however, she does not have any specific details yet, but the hope is to be reimbursed for some of the relocation costs. This temporary move allows time to look at where the TPO wants to be located; it is important that the location is central to everyone. The TPO is currently looking at its options and hopes to have something to present in the next couple of months.

Ms. Nicoulin announced the TPO's Recording Secretary, Ms. Debbie Stewart, is leaving the TPO; she has worked for the TPO for more than six years and will be missed. She is leaving to advance her career with another agency. Her last day will be April 5, 2023.

Vice Mayor Smith stated that Ponce Inlet is happy to have her.

Mayor Chasez commented that Ms. Nicoulin and the Executive Committee did a wonderful job with the temporary move; it is encouraging that the insurance company may come back with something. She does not think the TPO should accept the first offer; it is worth the struggle to come out better.

#### VII. River to Sea TPO Board Member Comments

Commissioner Johnson stated that although FDOT is on top of it, truck parking on the interstate highway system is getting to be very critical and unsafe. There are "no parking" signs, but the trucks are parking there anyway. The Lytx Corporation has put together a plan where they note the areas trucks are parking, and are notifying the trucking companies if those areas are unsafe to park so they can contact the driver to move. There are over 3.5 million trucks on the state highway system and only just under 300 truck parking spaces. He wants members to be aware of this issue and that something must be done; it is very unsafe, especially at night.

Chairperson Cloudman commented that it has been a while since an update has been given on FDOT's truck parking study.

Ms. Hinson replied that the truck parking study is ongoing; she is not sure where they are with the study at this time but will follow up and provide the information back to the TPO to distribute.

Council Member Reinhart thanked the TPO for the TPO 101 presentation; as a new board member, he was unaware of the process. He has concerns within Volusia County District 2 regarding a state road, Beville Road; it is a major access road with the construction of the Amazon distribution center and future construction plans for that area; it is residential on the other side of Beville where lighting and speeding are issues. One of FDOT's major focuses is on safety; Beville Road is a dangerous road and something needs to be done. He does not know if another traffic signal is needed but drivers are using Yorktowne Road to avoid the intersection at Clyde Morris Boulevard and Beville Road; it will be even busier when the new Publix opens.

#### VIII. River to Sea TPO Chairperson Comments

Chairperson Cloudman thanked Ms. Stewart for her work at the TPO and wished her well in her new endeavor.

**WHEREAS**, the River to Sea Transportation Planning Organization (TPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Volusia County and portions of Flagler County inclusive of the cities of Flagler Beach, Beverly Beach and portions of Palm Coast and Bunnell; and



### A. PRESENTATION AND DISCUSSION OF THE SR A1A RESILIENCY PLAN

### Background Information:

Representatives from the Florida Department of Transportation (FDOT), Flagler County, the city of Flagler Beach, and Volusia County have been working to develop options to repair and strengthen approximately 13 miles of SR A1A in Flagler and Volusia counties. The mission of the SR A1A Resiliency Strike Team is to make the Scenic A1A System, including the roadway, beaches, and dunes serviceable, functional, and resilient for decades to come. In addition to staff from FDOT and local governments, the planning effort has included coordination with representatives from the U.S. Army Corps of Engineers and the Florida Department of Environmental Protection. The team is also coordinating with other state and federal agencies.

The SR A1A Strike Team enlisted the help of coastal engineers to survey the existing conditions, understand the most vulnerable areas, and develop a list of options for consideration. The engineers and strike team members have reviewed and evaluated options based on several factors, including constructability, environmental and wildlife impacts, aesthetics, maintenance needs, cost/cost sharing, permitting needs, recreation, resiliency, right-of-way needs, parking, and public access. Community input has been vital to the process. FDOT hosted Community Listening Sessions in January in Volusia and Flagler counties to hear feedback about the options. The purpose of the public meetings was to introduce the recommendations and obtain input.


As a result of the planning efforts, FDOT proposes the following initial recommendations for protecting the SR A1A corridor:

- Proceed with the U.S. Army Corps of Engineers Beach Renourishment Project from South 28<sup>th</sup> Street to South 7<sup>th</sup> Street in Flagler Beach
- Construct a buried wall from Sunrise Avenue to Marlin Drive in Volusia County
- Construct a buried wall starting a half mile north of Highbridge Road in Volusia County to South Central Avenue in Flagler County.
   The plan also includes safety recommendations such as new pedestrian crossings that FDOT will consider as part of upcoming projects.

FDOT staff will provide an overview of the SR A1A Resiliency Plan.

- The National Safety Council reports that cell phone use while driving leads to 1.6 million crashes each year
- Texting while driving is 6x more likely to cause a crash than driving drunk
- Nearly 1,000 cyclists are killed in crashes in the US each year
- A recent study from the University of Nebraska Medical Center indicates that distracted drivers are to blame for more and more fatal bicycle and pedestrian accidents. Between 2005 and 2010, bicycle deaths related to distracted driving went up by 30 percent
- A study of college students found 50% of participants reported sending texts while driving on the freeway, 60% while in stop-and-go traffic, and 87% at traffic lights



### **OVERVIEW**

This document highlights key target setting provisions of Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) performance management requirements for state Departments of Transportation (DOT), Metropolitan Planning Organizations (MPO), and public transportation providers.\*

### **TRANSPORTATION PERFORMANCE MANAGEMENT FRAMEWORK**

Federal transportation law requires state DOTs and MPOs to implement Transportation Performance Management (TPM), a strategic approach to making investment and policy decisions to achieve performance goals. TPM uses past performance levels and



forecasted conditions to measure progress toward strategic goals as a means to guide investments.

Three FHWA Performance Measures (PM) rules and two FTA transit rules establish various performance measures to assess highway safety (PM1), bridge and pavement condition (PM2), system performance and freight movement (PM3), transit asset management (TAM), and transit safety. The FHWA and FTA Planning Rule and the performance measures rules also specify how MPOs should set targets, report performance, and integrate performance management into their Long Range Transportation Plans (LRTP) and Transportation Improvement Programs (TIP).\*

### Long Range Transportation Plans

#### The LRTP must:

- » Describe performance measures and targets used in assessing the performance of the transportation system.
- » Include a System Performance Report that:
  - Evaluates the performance of the transportation system with respect to performance targets.
  - Documents the progress achieved by the MPO in meeting the targets.
- » Integrate the goals, objectives, performance measures, and targets described in other plans and processes required as part of a performance-based program.

### Transportation Improvement Programs

#### The TIP must:

- Reflect the investment priorities established in the LRTP.
- Be designed such that once implemented, it makes progress toward achieving the performance targets.
- Include a description of the anticipated effect of the TIP toward achieving

## TARGET SETTING OPTIONS

The Florida Department of Transportation (FDOT), the MPOs, and public transportation providers set their respective performance targets in coordination with one another. All MPOs establish a target for each applicable performance measure by one of two options:

## Support the target established by FDOT or the public transportation provider(s).

The MPO agrees to plan and program projects so that they contribute toward the accomplishment of the state or public transportation provider(s) target.

### Establish own target.

The MPO coordinates with FDOT or the public transportation provider(s) regarding the methodology used to develop the target and the proposed target prior to establishing a final target.

For the **PM1, PM2, and PM3 measures**, MPOs must establish their targets no later than 180 days after FDOT sets its targets. For the **transit asset management and safety measures**, MPOs are not required to establish transit targets annually each time the public transportation provider(s) establishes targets. Instead, MPO transit targets must be established when the MPO updates the LRTP. MPOs will reflect current public transportation provider(s) targets in the updated TIP.

OR

## ASSESSMENT OF SIGNIFICANT PROGRESS

FHWA will not assess MPO target achievement. However, FHWA and FTA will review MPO adherence to performance management requirements as part of periodic transportation planning process reviews.

The TIP must include the most recent reported performance and targets as well as a description of how the investments contribute to achieving the targets. The LRTP must include a System Performance Report that discusses performance and the progress achieved in meeting targets.

### ASSESSMENT OF SIGNIFICANT PROGRESS

FHWA will determine if FDOT has made significant progress toward the achievement of each 2-year or 4-year statewide target if either:

- » The actual condition/performance level is better than the baseline performance; or
- » The actual performance level is equal to or better than the established target.

FHWA's determination of significant progress toward the 2021 bridge and pavement targets is anticipated in March 2023.

FHWA will not assess MPO target achievement. However, FHWA and FTA will review MPO adherence to performance management requirements as part of periodic transportation planning process reviews.

### **MINIMUM CONDITIONS**

Every year, FHWA will assess if FDOT is meeting federal minimum condition standards for NHS bridges and Interstate pavements. If it is not, FDOT must obligate a specified percentage of available funds for maintenance of these facilities.

### FDOT IS ON TRACK TO MEET MINIMUM CONDITION STANDARDS

- » Bridge: No more than 10 percent of total deck area of NHS bridges classified as Structurally Deficient (*Poor* condition) for three consecutive years.
- » **Pavement:** No more than 5 percent of the Interstate System in *Poor* condition for most recent year.

### **OVERVIEW**

<u>The third Federal Highway Administration (FHWA) performance management rule</u> establishes measures to assess the reliability of passenger and truck freight travel on the National Highway System (NHS) and the process for the Florida Department of Transportation (FDOT) and Florida's Metropolitan Planning Organizations (MPO) to establish and report their targets.\*

FHWA's determination of significant progress toward the 2021 interstate reliability and truck reliability targets is anticipated in March 2023. If FDOT does not make significant progress toward achieving a reliability target, it must document the actions it will take to achieve the target. For the truck reliability measure, it must provide additional freight congestion analysis and documentation.

FHWA will not assess MPO target achievement. However, FHWA and FTA will review MPO adherence to performance management requirements as part of periodic transportation planning process reviews.

## LEGISLATION TO EXPAND ACCESS TO FLORIDA'S WILDLIFE CORRIDOR SIGNED INTO LAW ON PATH OF THE PANTHER DAY

Bill to connect Corridor to SUN Trail Network and trail towns across Florida's Heartland Becomes Law

**Tallahassee** — Senate Bill 106, Florida Shared-Use Nonmotorized Trail Network, legislation by Senator Jason Brodeur (R-Sanford) to expand access to Florida's iconic Wildlife Corridor, was signed into law earlier today by Governor DeSantis. A top priority of Florida Senate President Kathleen Passidomo (R-Naples), the bill would connect the corridor to Florida's Greenways and Trails System and the SUN Trail Network, as well as recreational pathways to heritage small towns across Florida. The Senate also adopted Senate Resolution 1732, recognizing April 11, 2023, as "Path of the Panther Day" in Florida to highlight the recovery of the Florida panther and celebrate the Florida Wildlife Corridor.

"Our wildlife corridor provides a unique opportunity to experience the wonder and beauty of Florida's heartland. With this legislation we have the chance not only to preserve this natural resource for future generations, but to expand access so more Floridians can walk, run, and bike from trail town to trail town, taking in all our great state has to offer," said Senate President Kathleen Passidomo (R-Naples) "I envision Florida's Wildlife Corridor as a top destination for recreational tourists from across the country and around the world. As I have said before, I believe this will be Florida's Central Park – a legacy we can be proud to leave for future generations of Floridians and visitors to enjoy."

Florida's Wildlife Corridor encompasses approximately 17.7 million acres, including almost 10 million acres of conservation lands. The corridor is being created through the state's purchase of development rights of farmers, ranchers, and other landowners who will be able to continue their operations in perpetuity and the lands will never be developed. From 2020-2022, under the leadership of Florida's Commissioner of Agriculture, former Senate President Wilton Simpson (R-Trilby), the Legislature appropriated \$600 million in funding available to expand the Wildlife Corridor.

"The legislation signed into law today includes \$200 million to connect the corridor to our trail system so more people across our state and around the world can experience Florida's unique natural habitat," said Senator Brodeur, who serves as Chair of the Senate Appropriations Committee on Agriculture, Environment, and General Government. "This significant expansion of access to Florida's iconic Wildlife Corridor will provide even more options for families, athletes, and adventure seekers to experience old Florida at its finest, safeguarding more of our wetlands, farmlands and ranchlands, while improving the visibility of our quaint, legacy trail towns across Florida's heartland." The Senate was joined for the adoption of Senate Resolution 1732 by conservation photographer and National Geographic Explorer Carlton Ward, Jr., whose photography is featured in the awardwinning film "Path of the Panther" and the book of the same name, highlighting conservation efforts and the urgency to protect the Florida Wildlife Corridor. Photographs taken by Mr. Ward are prominently displayed in the Office of Senate President Kathleen Passidomo and featured during the month of April 2023 on the 22nd floor observatory and gallery of the Capitol in Tallahassee.

The Florida Shared-Use Nonmotorized (SUN) Trail Program, a priority of former Florida Senate President Andy Gardiner (R-Orlando), was created in 2015 to support the establishment of a statewide system of interconnected multi-use trails for bicyclists and pedestrians through coordination between the Florida Department of Environmental Protection (FDEP) and the Florida Department of Transportation (FDOT). The program receives funding from a portion of the existing fees paid when new vehicle registration fees are paid. The FDOT also dedicates other resources, such as federal grant funds, when available, to build bike and pedestrian trails that are part of the SUN Trail Network.

SB 106 formally connects the corridor to the state trail system, extending the SUN Trail Network to lands of the Florida Wildlife Corridor, which will include components that connect to nature trails, loop trails, or other points of public access wholly within a single park or natural area as potential parts of the SUN Trail Network. To fund expansions that connect the SUN Trail to the corridor, as well as the construction of shared-use nonmotorized trails in these areas, the bill increases from \$25 million to \$50 million the annual amount allocated to the SUN Trail Network from motor vehicle registration fees. The bill also appropriates \$200 million from the General Revenue Fund to the FDOT as a nonrecurring major investment to boost the planning, design, and construction of the SUN Trail Network. The legislation also codifies an existing campaign of the FDEP to recognize communities located along or in proximity to long-distance nonmotorized recreational trails as "Trail Towns," with guidance to Visit Florida for promoting trail-based tourism.

The bill requires that trail projects located within the Wildlife Corridor, to the greatest extent possible, use previously disturbed lands, such as abandoned roads and railroads, utility rights-of-way, canal corridors and drainage berms, and permanent fire lines. Further, FDOT is directed to minimize gaps between trail segments and to ensure, to the greatest extent possible, that local support exists for projects and trail segments, including the potential for dedication of local funding and of contributions by sponsors to support trail maintenance, which may include those private landowners who make their land, or property interests in such land, available for public use as a trail.
