- Recommended Approval of Resolution 2013-## adopting the joint participation agreement (JPA) with FDOT for XU Traffic Ops/ITS/Safety feasibility studies

  a CAC member wanting questions answered to submit a list of questions regarding the interchange in
  writing to the city of Port Orange and Volusia County so they can be addressed
- Received the FDOT report and Volusia County Construction report; informed the construction report would be sent via email to the members

- Received TPO staff update on reapportionment and SunRail and announced an ITSS meeting on an intermodal study undertaken by FDOT to look at identifying a multimodal hub location on June 26 at 5:00 p.m. at Embry Riddle Aeronautical University; directed Volusia County Engineering to forward a copy of the scope of work to the members

  - → Add freight as one of the possible subcommittees under Section 5.5
  - → Making the clause on reporting absences to a TPO staff member consistent throughout the document for all of the advisory committees
  - → references to Volusia and Flagler County support staff as non-voting members of committees should be clarified to indicate they are "advisory" non-voting members and changing the reference in section 7.1 F and G
  - → clarify that if a quorum is lost during a meeting, no further action will be taken on action items but presentation and discussion can continue
  - → In the section on subcommittees, the first order of business shall be to elect a chair add that a vice chair should be elected as well
- Reviewed the draft Volusia TPO 2013 Transportation Priority Project Lists; recommended a number of changes

- Directed FDOT to provide clarification on project #2 on the XU Traffic Ops/ITS/Safety "C" list, SR 400 (Beville Road)-SR 5A (Nova Road) Mast Arm Installation
- Approved a motion to recommend that the three LED signal projects that had been removed from the
  proposed draft priority lists at the request of FDOT be reinstated for submission in August to be
  retained on the "B" List with the same rank/score if federal eligibility requirements to be a part of a
  system-wide, coordinated plan are met by the August committee meetings (Volusia County staff
  agreed to provide the system plan document)
- Received a presentation on the interchange at I-95 and Pioneer Trail from Volusia County
- Received the FDOT report and Volusia County Construction report and informed that the construction report would be provided to the members via email
