#### 1. Call to Order / Roll Call / Determination of Quorum

The Volusia-Flagler Transportation Planning Organization (TPO) Executive Committee meeting was called to order at 9:01 a.m. by Chairperson Eric Sander. It was determined through roll call that a quorum was physically present. The meeting was held in a hybrid format with remote participation provided; five voting members were physically present.

#### 2. Public Comment/Participation

There were no public comments.

#### 3. Business Items

#### A. Review and Recommend Approval of Executive Director's Performance Evaluation

MOTION: A motion was made by Commissioner Belhumeur to recommend approval of the Executive Director's Performance Evaluation. The motion was seconded by Vice Mayor Gillis.

Ms. Nicoulin explained that the Executive Committee is designated to perform the annual evaluation of the Volusia-Flagler TPO Executive Director, as required by the TPO's contract with the Executive Director. The scores were compiled, and the results were presented.

#### The motion carried unanimously.

The Committee then discussed a salary increase recommendation for the Executive Director. Cost-of-living and merit increases were discussed. It was noted that the Executive Director automatically received the cost-of-living increase

that the TPO staff receives. Members praised Ms. Nicoulin for her work through adversity, including several office relocations and a short staff. A three-percent merit salary increase was recommended.

MOTION: A motion was made by Commissioner Belhumeur to recommend approval of a 3% merit raise based on the Executive Director's current salary (before the 3% cost-of-living increase). The motion was seconded by Council Member Robins and carried unanimously.

#### B. Review and Recommend Approval of FY 2025/26 TPO Budget

MOTION: A motion was made by Commissioner Belhumeur to approve the FY 2025/26 TPO Budget. The motion was seconded by Vice Mayor Gillis.

Ms. Nicoulin explained the TPO's draft budget, including the revenue sources and staff salary and fringe benefit expenses.

Discussion about the draft budget continued, including the need to replace the server.

The motion carried unanimously.

#### C. Review and Approval of the May 7, 2025 Executive Committee Meeting Minutes

MOTION: A motion was made by Council Member Robins to approve the May 7, 2025 Executive Committee minutes. The motion was seconded by Commissioner Belhumeur and carried unanimously.

#### D. Review and Approval of the Draft June 25, 2025 TPO Board Agenda

MOTION: A motion was made by Vice Mayor Gillis to approve the draft June 25, 2025 TPO Board agenda. The motion was seconded by Council Member Robins.

Ms. Nicoulin reviewed the draft TPO Board Agenda, including an amendment to the TPO Budget, her performance evaluation, and the cancellation of the July meetings. She noted that there will not be a TIP amendment, however, there will be the adoption of the TIP, the adoption of the LOPP, the approval of the Vision Zero Action Plan, and approval of the SS4A grant submission. It was noted that there will be no need for a separate presentation item for the LRTP.

Councilman Sander asked if there wasn't a quorum for the TPO Board meeting in June, could he still execute the resolutions? Ms. Nicoulin stated that yes, resolutions can still be signed without a quorum per the TPO Bylaws.

The motion carried unanimously.
