I. Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance

The meeting of the Volusia Transportation Planning Organization (TPO) Bicycle/Pedestrian Advisory Committee (BPAC) was called to order at 3:00 p.m. by Chairperson Robert Storke. The roll was called and it was determined that there was a quorum.

MOTION: A motion to approve the Consent Agenda was made by Ms. Devies. The motion was seconded by Ms. Merens and carried unanimously.

IV. Action Items

- A. Nomination and Election of BPAC Chair

MOTION: A motion to nominate Ms. Nicoulin for BPAC Chair was made by Ms. Devies. Ms. Nicoulin declined the nomination due to time constraints.

Mr. Harris stated the current BPAC bylaws state the Chair and Vice Chair meet with TPO staff to create meeting agendas. In practice, this doesn't happen and the draft bylaws of the River to Sea TPO have been changed to reflect it. Approximately 90% of the duties of the Chair are to preside at the BPAC meetings and represent the BPAC at the TPO board meetings. TPO board meetings are the fourth Wednesday of the month at 9:00 a.m. and usually last two hours. The Chair may also attend outside events, but that is optional. According to the bylaws, the Chair can serve two consecutive terms, so the current Chair (in his first term) and the voting members here today are eligible for nomination.

MOTION: *A motion to nominate Mr. Storke for BPAC Chair was made by Ms. Jones. The motion was seconded by Mr. Mostert and carried unanimously.*

ELECTION: *The election of Mr. Storke for BPAC Chair was unanimous.*

B. Nomination and Election of BPAC Vice Chair

Mr. Harris stated the Vice Chair presides over BPAC meetings and assumes the duties of the Chair in the absence of the Chair.

MOTION: *A motion to nominate Mr. Mostert for BPAC Vice Chair was made by Ms. Nicoulin. The motion was seconded by Ms. Devies and carried unanimously.*

ELECTION: *The election of Mr. Mostert for BPAC Vice Chair was unanimous.*

C. Review and Approval of the draft Bylaws of the River to Sea TPO

Ms. Bollenback stated several months ago, a subcommittee of the TPO board met to revise the bylaws. Shortly after the first meeting, they agreed to make a comprehensive review of the bylaws, which included consolidation of the committee bylaws. A complete draft of the consolidated bylaws is in the agenda packet. The other committees are reviewing the draft this month for final approval in August. The changes to the BPAC section of the bylaws (section 7) are underlined. The changes are:

- The addition of nonvoting members representing Palm Coast and Flagler County
- A requirement that BPAC members reside in the area they represent
- BPAC members continue to serve until they are reappointed or replaced
- Reference to the Subcommittee of Administrative Affairs has been eliminated
- Reference to a formal report (to the board) by the BPAC Chair has been eliminated
- Language regarding the day and time of monthly meetings was revised to eliminate annual reaffirmation
- Language revised under emergency and special meetings from “reasonable notice” to “two business days’ notice”
- Language revised to state that a quorum is required for action items and if a quorum is not maintained during a meeting, then no action can be taken
- Public comment is generally limited to 3 minutes
- Language regarding the involvement of the BPAC in public relations and outreach efforts has been eliminated
- Language regarding subcommittees has been added to establish a Chair for subcommittees, define how long they are to convene and to report back to the entire BPAC

Ms. Devies stated the calculation of quorum will be 33%. Ms. Bollenback responded that it is difficult to obtain representatives from small cities. The small city alliance has a rotating representation. The bylaws subcommittee did not want to penalize the BPAC by having it meet a quorum with nonvoting/rotating representation. Note the name change to "River to Sea TPO."

Ms. Campbell asked how the meeting is monitored for the change in quorum. Ms. Bollenback responded the recording secretary will notify the BPAC when there is not a quorum.

Mr. Clark asked if the school board is a voting member. Mr. Harris responded the school board is a nonvoting member. The notable change is the addition of the Flagler County School Board as a nonvoting member.

Ms. Hickey asked how Orange City will be represented on the BPAC with the change in status from small city to full voting board member. Ms. Bollenback responded that it will have to be looked into.

Dr. Aufdenberg asked if all of the small city representatives get a vote. Ms. Bollenback responded yes.

MOTION: A motion to recommend approval of the draft bylaws of the River to Sea TPO was made by Mr. Mostert. The motion was seconded by Ms. Grenham and carried unanimously.

V. Presentations and Discussion Items

A. Presentation on the SR 40 Project Development & Environment (PD&E) Study

Ms. McGehee provided handouts and stated preparations are underway for a public hearing of the SR 40 PD&E study. The public hearing will be June 25th from 5:00 p.m. to 7:00 p.m. at Riverbend Community Church in Ormond Beach. The study covers an area two miles long along SR 40 from Breakaway Trails to Williamson Blvd. The project will widen SR 40 from 4 to 6 lanes. Bicycle and pedestrian facilities will be enhanced along the corridor. The study is a State Environmental Impact Report and uses no federal funds. The study should be complete by the fall of this year. No future phases of the project are funded beyond the PD&E study.

Mr. Freeman stated the only modifications to the I-95 interchange are an extension of right turn lanes. Other widening projects along SR 40 are: from US 17 to SR 11 (2 to 4 lanes), from SR 11 to Cone Road, a resurfacing project from Tymber Creek Road to Parrot Drive, widening along Tymber Creek Road from SR 40 to Peruvian Lane and along SR 40 from Marion County to Volusia County. A goal is to maintain level of service C to the year 2020. An existing 8 foot wide sidewalk will be replaced by a 12 foot wide shared use path on the north side of SR 40. A 5 foot wide sidewalk will be on the south side of SR 40. Noise barriers were analyzed, but are not approved for this project.

Dr. Aufdenberg asked if the state considered improving the bicycle lanes, but not the travel lanes. Mr. Freeman responded no, since the travel lanes need to be improved to maintain a level of service C.

Mr. Bustos stated a lot of pavement is being added at the intersections, which means longer crossing distances for pedestrians and bicyclists. Mr. Freeman responded 3.5 feet/second crossing times will be maintained.

Ms. Carter stated the intersection of SR 40 and Williamson is one of the intersections that FDOT has received requests for improvements from visually impaired persons who use transit services.

Ms. Idler stated the entire intersection is dangerous to cross for visually impaired pedestrians.

Ms. Nicoulin asked if the right turn on red status (at Williamson Blvd.) will be changed to no right turn on red. Mr. Freeman responded probably not.

B. Presentation on the draft Prioritized List of Bicycle/Pedestrian Projects

Mr. Harris stated the draft prioritized list of bicycle/pedestrian projects has been ranked by score in Tier B and Tier C. The project submitted by the City of Palm Coast has been highlighted, as it is not currently in our planning area. This project will also be on a separate list and may be merged into a single priority list at some time in the future. Note that some projects have moved up or down according to the rankings by score.

Dr. Aufdenberg stated the local match commitment for the Seminole Woods Blvd. Shared Use Path is greater than 10%. Mr. Harris said he will check on it.

VI. Staff Comments

Mr. Harris stated the St. Johns River to the Sea Loop Trail Summit and National Trails Day Celebration took place since the last BPAC meeting and both events went well. Special thanks to BPAC members who attended these events, Andrew Johnson for help in organizing the summit and to Amanda Vandermaelen for inviting the TPO to the National Trails Day Celebration. Ms. Nicoulin has volunteered to organize bicycle rides for the upcoming Share the Road/Celebration of Cycling event in October.

VII. Information Items

VIII. BPAC Member Comments

Mr. Pouzar stated he was appalled that some municipalities proposed 5 foot wide bicycle/pedestrian facilities at the summit.

Mr. McCord stated there is a big drop-off in the amount of XU funds in the next 3 years for funding projects. Mr. Harris responded the XU fund is not expanding as fast as the number of projects on the priority list. Some projects on the priority list will have to wait longer than expected for funding, but the TPO will continue to try to leverage funding that is available for these projects. Remember, the TPO's policy is to keep projects on the priority list until they have been completed.

Ms. Devies announced her resignation (her last BPAC meeting). Ms. Devies thanked the BPAC.

Mr. Walters stated the Spring to Spring Trail segment west of the DeBary Avenue Bypass narrows to an 8 foot wide sidewalk. There is a wall on one side and it is a dangerous area.

Ms. Nicoulin stated the Share the Road/Celebration of Cycling event will take place on October 25-27, 2013. There will be educational programs, self-guided rides and a mountain bike event at Chuck Lennon Park.

Mr. Bustos added that the event will also feature workshops for government staff and elected officials.

Ms. Carter stated MAP-21 created the Transportation Alternatives (TA) Program. The guidance provided today mentions projects eligible for TA funding are also eligible for Surface Transportation Program (STP) funding, a much larger funding category.

IX. Adjournment



Background Information:

The Volusia TPO participates in the Central Florida Metropolitan Planning Organization Alliance (CFMPOA). The group is comprised of six MPOs/TPOs serving the Central Florida area which meet quarterly to discuss regional transportation matters and to coordinate transportation activities. Over the past several months, the CFMPOA members have been working to develop a concept for prioritization of regional projects including strategic intermodal systems (SIS), regional trails and regional transit.

A draft concept is provided with this agenda and is being used to guide the development of regional priority project lists. The CFMPOA, based on feedback from the six MPOs/TPOs, has developed a draft set of lists to reflect updated priorities being developed by each MPO/TPO as part of the current call for projects. The regional trails project priority list is provided with this agenda packet for your review.

Regional Prioritization Initiative April 2013

The Concept

The Central Florida MPO Alliance has been active as a six-MPO forum for more than a decade, meeting quarterly to address regional transportation issues and legislative items. Although the group has been successful in building consensus on regional transportation issues, the Alliance does not have a formal role in the prioritization process with the Florida Department of Transportation. Each member-MPO individually engages with FDOT to establish priorities for transportation funding, however, the Alliance has never acted on a regional list of priorities.

An opportunity awaits for each MPO to work through the CFMPOA to collectively benefit from a regional prioritization process. By working as an Alliance to prioritize appropriate regional projects, each MPO will individually benefit while also benefitting the Central Florida Region. Through a unified approach, additional funding resources can be leveraged by working as an Alliance with the FDOT.

The Project Categories

Not all transportation projects and funding categories are appropriate for a regional approach. However, three categories have emerged through the consensus-building process. Strategic Intermodal System projects are of regional and statewide importance. Therefore SIS projects, both interstate and non-interstate projects, would be addressed by the Alliance in order to potentially leverage increased transportation resources for the region. This category would not include US highways and state roads that are funded through the FDOT's Other Arterials program.

As a result of the "Close the Gaps" initiative that began in Central Florida in 2012, Regional Trails would be a second category of transportation projects to be prioritized by the Alliance. Through this regional approach, greater resources could be leveraged by prioritizing among the five MPOs within FDOT District 5 the trail projects that could most quickly lead to completed systems of trails that connect populations and attractions, thus resulting in eco-tourism opportunities for the region. This category would include regional, showcase trails, not sidewalks, local trails and other enhancement projects.

The third category for prioritization would include regional transit projects that contribute to connectivity on a regional scale. Transit projects that cross county lines and MPO boundaries could be considered for the Alliance prioritization process. Mass transit projects like SunRail and connections to the commuter rail system would be considered for regional priority. This category would not include localized transit projects.

The Process

Each MPO adheres to an annual prioritization process to establish funding needs within individual MPO Areas. That annual process typically begins in April-May and usually concludes in August of each year in order to meet the Sept. 1 statutory deadline. September-November, the FDOT begins the process of gaming, which results in new projects entering into the FDOT's Tentative Work Program or programmed projects being advanced in the Tentative Work Program. The five District 5 MPOs working on a unified priority list will empower the FDOT to incorporate the actions of the Alliance into the new work program.

The process will respect each MPO's order of projects within the three aforementioned categories. The CFMPOA prioritization process will follow the order within each MPO's list while melding the five lists into one regional list. Costs, the scale of magnitude of projects and the cost-benefit factor of projects will be considered, as well as the urbanized population and visitor population served by projects. To achieve a sense of equity, effort will be made to rotate as feasible among the five MPOs to ensure that each MPO's priority list is respected.

The Timeline

In order to meet the FDOT's deadline for release of the Tentative Work Program, each MPO will individually follow its own process. Meanwhile, the CFMPOA will review and recommend on a draft list of priorities beginning at the April meeting. Opportunity for further comment will remain open from April until July. Just prior to the July meeting, the executive directors will reconvene to refine the priority list for presentation to the Alliance. Based on action by the CFMPOA, the priority list will be compared to each individual MPO's priority list to ensure consistency with individual MPO priorities. Final action will occur in August on each individual MPO's List of Priority Projects.

Once each MPO has taken action and transmitted their LOPPs to the FDOT, the executive directors will reconvene to review actions and to make a determination if changes are needed to the CFMPOA priority list. The finalized list will be presented to the Alliance at the October meeting for ratification and the list will be formally transmitted to the FDOT. From the time of adoption of each individual MPO's LOPP until ratification by the Alliance, the executive directors will remain in communication

with FDOT personnel on the pending CFMPOA priority list to ensure awareness of progress on the regional effort.

The Outcomes

Once the CFMPOA ratifies the list in October, a landmark moment occurs in Florida as an unprecedented level of regional transportation coordination is formalized. For each of the three project categories, the potential outcomes are unique. For SIS priorities, the regional list affords the Central Office of FDOT an opportunity to look at the Central Florida Region in a new manner. When examining the potential funding of mega-projects, a unified list incorporating the five MPO's and nine counties of District 5, and potentially Polk County and the Polk County TPO, will enhance the process between MPOs and the FDOT of establishing priorities and programming funds. The planned outcome is the leveraging of greater resources to the region.

In light of the changes in federal funding opportunities for regional trail projects, a unified list of regional trail priorities is critical to meeting the goals of the "Close the Gaps" initiative. Leveraging additional FDOT funds is the focus of the regional trail priority list. By creating a master list of regional trail projects, ordered by phases so that shovel-ready projects are top priority, District 5 will have an opportunity to program funds for multiple projects. The result would be the expedited construction of multiple trail segments that will begin closing the gaps in the regional network. This approach will catalyze an eco-tourism opportunity of national and international proportions.

Regarding regional transit projects, the CFMPOA process is focused on mass transit that has regional implications beyond localized transit services. The Alliance list is intended to coalesce efforts throughout the region into a unified approach. Rail and bus-rapid-transit projects would be the focus of the CFMPOA list, while localized transit services would remain part of each individual MPO's prioritization process. This approach will aid the FDOT in developing a regional mass transit vision for Central Florida beyond the initial phases of SunRail.





Proposed Regional Transit Priorities

Proposed transit priorities are focused on high capacity rail or bus projects requiring a significant investment of federal, state and local funds. These are shown in three tiers: (1) projects currently underway; (2) prospective projects currently being studied; and (3) future projects that will be studied. Privately-funded projects are shown for information purposes.

- SunRail - Phase I (DeBary - Sand Lake Road)
- SunRail - Phase II (DeBary-Deland; Sand Lake Road-Poinciana)
- East-West Lymmo
- Parramore Lymmo

Prospective Transit Projects Currently Being Studied or in Development

- Flagler Line (Jacksonville to Miami in the FEC Corridor)*
- OIA Refresh Alternatives Analysis
- US 441 Corridor Alternatives Analysis
- SR 50 Alternatives Analysis
- US 192 Alternatives Analysis

Outcomes of these studies will determine whether a high capacity transit project should be advanced and, if so, the appropriate technology and cost.

Future Transit Projects That Will Be Studied

- SunRail extension to Daytona Beach International Airport



JOINT RESOLUTION #2013-01

of the

Central Florida MPO Alliance (CFMPOA) and the West Central Florida MPOs Chairs Coordinating Committee (CCC) supporting the implementation of Florida's Coast-to-Coast Connector Project, requesting the allocation of funds by the Florida Department of Transportation and pledging the assistance of member MPOs and TPOs to close the existing gaps in the Connector

WHEREAS, the Central Florida MPO Alliance and the West Central Florida MPOs Chairs Coordinating Committee collectively comprise 12 metropolitan planning organizations and transportation planning organizations encompassing 17 counties in the Central Florida mega-region; and

WHEREAS, the goal of the annual joint meeting of the CFMPOA and the CCC is to promote and coordinate regionally-significant, multi-modal transportation improvements across the mega-region; and

WHEREAS, the 275-mile Coast-to-Coast Connector (Connector), identified as having statewide economic benefit, would create a safe and continuous multi-use path from the Atlantic Ocean, through the heart of the Tampa-Orlando mega-region, to the Gulf of Mexico, and

WHEREAS, 200 miles of the Connector, or 75 percent, is already open to the public or funded for completion, and

WHEREAS, trails are the number one community amenity sought by American homebuyers; and

WHEREAS, information about cycling is among the most requested from tourists contacting Visit Florida, and

WHEREAS, the annual economic impact of cyclists is estimated to be nine times the one-time cost to build bicycle facilities, and

WHEREAS, three existing Central Florida trails produce \$42 million of economic benefit annually and support 516 jobs, and

WHEREAS, trails have rejuvenated local communities and added to Florida's growing eco-tourism industry, and

WHEREAS, the Coast-to-Coast Connector project received the support of the House and Senate in the form of a \$50 million special appropriation in the 2013 Budget, which was later vetoed by the Governor, and

WHEREAS, letters of support were received from metropolitan planning organizations, transportation planning organizations, county governments and civic and community organizations; and

WHEREAS, closing the 72 miles of gaps between existing trails, from Canaveral National Seashore on the east coast to St. Petersburg on the west, will produce the longest continuous multi-use trail in the state and one of the longest in the country.

NOW THEREFORE, BE IT RESOLVED by the Central Florida MPO Alliance and the West Central Florida MPOs Chairs Coordinating Committee that, we, jointly:

1. Support the timely completion of the Coast-to-Coast Connector Project.
2. Request the Florida Department of Transportation include \$50 million in the Five-Year Work Program to complete the Coast-to-Coast Connector Project.
3. Pledge the cooperation and assistance of our member MPOs and TPOs to aid the Florida Department of Transportation, the Florida Department of Environmental Protection Office of Greenways and Trails and other stakeholders in prioritizing, planning and implementing the Coast-to-Coast Connector Project.



B. Presentation on the Chuck Lennon Park Mountain Bike Trail

Background Information:

Chuck Lennon Park is located at 5000 Greenfield Dairy Road in DeLeon Springs, Florida. The park is adjacent to DeLeon Springs State Park and was developed by Volusia County's Parks, Recreation and Culture Division with financial assistance provided by the Florida Department of Natural Resources through the Florida Recreation Development Assistance Program. The 136-acre park has covered pavilions, grills, restrooms, two playgrounds and a 5.8 mile single track mountain bike trail. It is well known among mountain bike enthusiasts and is regarded as one of the top mountain bike trails in Florida. The trail is classified as an "intermediate to advanced" mountain bike trail that includes two advanced technical skills areas that include jumps, quick descents, and manmade/natural balance features.

The Volusia County Council approved a license agreement for the Chuck Lennon Park mountain bike trail at their June 6, 2013 meeting. The license agreement is between Volusia County and the Southern Off-Road Bicycle Association (SORBA) and Flagler Area Biking, a chapter of SORBA. The agreement requires SORBA to provide ongoing trail system maintenance, weekly trail inspections and safety/hazard reports to the county. SORBA also is required to maintain adequate indemnity and insurance coverage as defined in the agreement. The term of the agreement is for one year. The agreement does not prohibit the public's use of the mountain bike trails or make SORBA liable for the actions of the general public not attributable to the negligence of SORBA. Staff from Volusia County Parks, Recreation & Culture Division have toured and inspected the trails with officials from SORBA and the International Mountain Biking Association (IMBA). Trail elements requiring modification for enhanced user safety have been completed. These include installation of GPS coordinates throughout the trail, installation of additional informational, regulatory and educational signage, identification of emergency extraction points and elimination of safety hazards. All emergency GPS information has been provided to the county's emergency response staff.

C. Presentation on Proposed Votran Fare Increase

Background Information:

In the upcoming budget year, Votran faces a projected increase to the general fund subsidy of an additional \$2 million forecasted in fiscal year 2015. Revenue generated by a fare increase would help to deal with this funding challenge. Currently, the fixed-route cash fare is \$1.25 and the day pass is \$3.00. These amounts are lower than the statewide average of other Florida transit systems. Votran's current fare structure has been in place since January 2007. Votran staff will address this item.


