B. REVIEW AND RECOMMEND APPROVAL OF THE DRAFT COMPLETE STREETS POLICY AND IMPLEMENTATION PLAN

BACKGROUND INFORMATION:

According to Smart Growth America's National Complete Streets Coalition, complete streets are designed and operated to enable safe access for all users, including pedestrians, bicyclists, motorists and transit riders of all ages and abilities. A Complete Streets Policy directs transportation planners and engineers to integrate a Complete Streets approach into their transportation practices, policies and decision-making processes to improve the entire street network.

The Walkability Action Institute Team, with the assistance of TPO staff and Kittelson & Associates, has been working on a local (specific to Orange City) and regional Complete Streets Policy and Implementation Plan for the TPO Metropolitan Planning Area (MPA). The Complete Streets Subcommittee will review and provide feedback on the enclosed regional policy and implementation plan. Supporting documentation is also included for reference purposes.
