#### I. Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance

The meeting of the Volusia Transportation Planning Organization (TPO) <u>Bicycle/Pedestrian</u> <u>Advisory Committee</u> (BPAC) was called to order at 3:02 p.m. by Chairperson Robert Storke. The roll was called and it was determined that there was a quorum.

#### II. Public Comment/Participation

None

#### III. Action Items

#### A. Review and Approval of June 12, 2013 BPAC Meeting minutes

Ms. Nicoulin stated Page 5 of the minutes should state the right turn on red status of the northbound I-95 off ramps.

MOTION: A motion to approve the June 12, 2013 BPAC meeting minutes with

correction was made by Ms. Campbell. The motion was seconded by

Ms. Grenham and carried unanimously.

### B. Review and Recommend Approval of the draft Prioritized List of XU Bicycle/Pedestrian Projects

Mr. Harris stated the draft Prioritized List of Bicycle/Pedestrian Projects contains the following changes since the last BPAC meeting: the Seminole Woods Blvd. Multi-Use Path has been placed on a separate list for the City of Palm Coast, Providence Blvd. Shared Use Path and Powerline Shared Use Path feasibility studies have been withdrawn by the City of Deltona.

Ms. Nicoulin asked about the separate list for the City of Palm Coast. Mr. Harris responded the priority list is scheduled for adoption in late August by the TPO Board. Reapportionment will not be finalized by that time, so projects in the City of Palm Coast will not be eligible for XU funds. Discussions are underway on how and when to merge the priority lists after reapportionment is finalized.

Dr. Aufdenberg asked if additional XU funds will be available once reapportionment is finalized. Mr. Harris responded yes, since XU funds are based on population, but the additional amount is expected to be very small.

MOTION: A motion to recommend approval of the draft Prioritized List of XU

Bicycle/Pedestrian Projects was made by Mr. Mostert. The motion was

seconded by Ms. Campbell and carried unanimously.

### C. Review and Recommend Approval of the Central Florida MPO Alliance Regional Trails Project Priority List

Mr. Harris stated the Central Florida MPO Alliance (CFMPOA) consists of MPOs and TPOs in Central Florida and the priority list is an attempt to create a regional list of projects that can be funded with the statewide allocation of TAP funds. Projects on the trails priority list are typically larger projects that are included on the Florida Office of Greenways and Trails plan. The priority list is divided into sections similar to the ones used by the Volusia TPO. The TPO board will be considering this list for adoption later this month.

Mr. McCord asked if the Spring to Spring Trail, Phases 5, 6 and 7B should be included on the list. Mr. Harris responded not all of the Spring to Spring Trail segments are on the priority list, just the top priorities.

Ms. Bollenback added the Spring to Spring Trail segments 5, 6 and 7B are Volusia County's Showcase Trails. The county requested the trails be placed on the priority list. In Volusia County, there is not a single trails priority list. FDOT has signaled that they will be using TAP funds at their discretion towards the regional priority list.

Ms. Carter stated the DeBary area between Dirksen Drive and the St. Johns River is a critical hub to connect trails in Seminole and Volusia Counties.

Ms. Bollenback stated the TPO is working on a TIP amendment to allocate TAP funds for the purchase of right-of-way for the East Central Regional Rail Trail Segment 4A (Guise Road to Gobblers Lodge Road).

Mr. Mostert asked about criteria for prioritizing trails on the CFMPOA list. Ms. Bollenback responded some of the trails are prioritized by other MPOs, which don't necessarily use the same criteria used by Volusia TPO. Some MPOs prioritize trail projects by negotiation.

Mr. Mostert asked if here was a downside of using the CFMPOA trails priority list. Ms. Bollenback responded no.

MOTION: A motion to recommend approval of the Central Florida MPO Alliance Regional Trails Project Priority List was made by Ms. Grenham. The motion was seconded by Mr. Mostert and carried unanimously.

#### IV. Presentations and Discussion Items

#### A. Presentation on Understanding Bicyclists and Roadways

Mr. Bustos stated traditionally, law enforcement training on bicycle and pedestrian law has been limited. Florida Bicycle Association (FBA) is working with FDOT and the Florida Public

Safety Institute to develop curriculum for the police academies. Short roll call videos for police officers in the field are also being developed. The first two modules are on the DVD "Understanding Bicyclists and Roadways."

["Understanding Bicyclists and Roadways" video was shown.]

Mr. McCord asked if the videos can be uploaded to the VTPO website. Mr. Harris responded yes.

Mr. Bustos stated additional funding is being requested for FBA to develop curriculum for the police academies.

Dr. Aufdenberg asked if there was a similar video to train motorists. Mr. Bustos responded no.

Ms. Winsett stated there is a lack of enforcement and police presence.

Mr. McCord stated the Pedestrian Crosswalk Safety Workshop held in Daytona Beach Shores was very enlightening.

#### B. Presentation on the Chuck Lennon Park Mountain Bike Trail

[A Volusia Magazine story about the Chuck Lennon Park Mountain Bike Trail originally aired on July 7, 2013 was shown.]

Mr. Phelps stated the Southern Off-Road Mountain Biking Association, part of the International Mountain Biking Association, has 35,000 members worldwide in all 50 states and 30 countries. The Chuck Lennon Park Trail is ranked in the top 5 mountain bike trails in Florida out of 162 trails. In the winter, 100-200 people ride the trail every day. An agreement with Blue Springs State Park has been signed to use their trails.

Mr. McCord asked if the mountain bike trails in Chuck Lennon Park are limited to biking. Mr. Phelps responded yes, but trails in Blue Springs State Park and in Flagler County are for hiking and biking.

Ms. Merens asked how to access the video. Mr. Harris stated it can be found on <a href="https://www.volusia.org">www.volusia.org</a> under Volusia Magazine archived stories.

#### C. Presentation on proposed Votran Fare Increase

Ms. Blanck introduced Mr. John Cotton as the new Votran representative to the BPAC. Ms. Blanck referenced handouts provided to the BPAC via email. Ms. Blanck stated last March a mini budget workshop took place with Volusia County Council and determined a budget shortfall was eminent. At that time, the county council asked Votran to assess saving initiatives for the budget. Last May, saving initiatives, which included fare increases and

service cuts, were reviewed with the county council. Votran discussed these initiatives with local municipalities on June 24th. In July, the county council directed Votran to conduct public involvement activities for the fare increase. The last Votran fare increase was in January, 2007. An assessment of the rider profile is conducted with each update of the Transit Development Plan. The last assessment was completed in 2011 as a survey on buses. The average Votran rider is a white female, between the ages of 16 and 24, earning less than \$10,000/year. Overall, 80% of Votran riders earn less than \$29,000/year. Votran ridership (fixed route) has increased 5.8% in 2011-2012 and 20% since 2008. Votran has stopped operating the Medicaid transportation for Volusia County. The costs per rider are \$24.26/trip after the \$2.50 copay for Gold service and \$3.23/trip after the \$1.25 copay for fixed route service. Flex route service is offered in New Smyrna Beach. Votran has no debt and no unfunded liabilities. Votran has generated cost savings of \$1 million/year. Fuel use has decreased from 875,000 to 797,000 gallons since 2007. Votran has entered into a partnership for trolley service. HVAC and roof upgrades will save \$16,000/year. A west side facility is expected to save \$35,000/year. Coolant and refrigerant savings are \$40,000/year. Fare revenue is \$2.8 million overall. Advertising revenue is \$7.391 million. Overall budget is approximately \$20 million. Proposed fares are \$2.50 for paratransit, \$1.50 for fixed route service (first phase) and \$1.75 for fixed route service (second phase). Five meetings will be held throughout the county to discuss the proposed fare increase.

Ms. Carter asked about ridership development. Ms. Blanck responded Votran is at capacity on many routes. There is competition for bicycle racks on Votran buses.

Mr. Mostert stated the option of eliminating night service is a concern.

Mr. Bustos asked if folding bicycles are allowed on Votran buses. Ms. Blanck responded yes, as long as bicycles do not take up extra seats when folded.

Ms. Merens stated the paratransit service is very economical.

#### V. Staff Comments

Mr. Harris stated a Pedestrian Crosswalk Safety Workshop was held on July 15<sup>th</sup> in Daytona Beach Shores. The workshop started in a conference room in the morning and continued at crosswalks in Daytona Beach Shores and New Smyrna Beach in the afternoon. The Town of Ponce Inlet participated and held additional crosswalk enforcement operations a few weeks later. The TPO provided in-street signs and warning flyers to participating agencies. An additional workshop is being planned.

#### VII. BPAC Member Comments

Mr. Mostert stated a bicycle safety campaign should be started.

Dr. Aufdenberg stated sharrows and signs indicating bikes may use full lane are posted in Salt Lake City, Utah.

Ms. Winsett asked about showing the Pedestrian Crosswalk Safety Workshop photographs or a presentation by the Ponce Inlet Police Chief to the Community Traffic Safety Team (CTST). Mr. Harris responded that he will contact the CTST Chair.

Mr. McCord stated construction will begin soon on the Herbert Street Sidewalk on the south side of the road from Silver Sands Middle School to Nova Road. Bike sharing roadway signs will also be installed.

Ms. Masters stated a program for schools to educate children on pedestrian right of way will be helpful.

Mr. Clark stated schools can distribute safety information through newsletters and other internal communication.

Mr. Harris stated the TPO makes presentations on bicycle and pedestrian safety to summer school Extended Day Enrichment Programs.

Mr. Clark stated a Mobile Safety City is in development as an educational tool to teach children safety lessons.

Ms. Haldeman asked about parking in Flagler County near Marineland. Mr. Johnson responded there is free parking in the River to Sea Preserve and on the east side of A1A.

Mr. Bustos stated the Bike Florida/FBA bicycle festival will take place October 25-27, 2013. A session for elected officials and planners will take place on October 26<sup>th</sup>. More information can be found on Bike Florida's website: <a href="www.bikeflorida.org">www.bikeflorida.org</a>.

Ms. Carter stated Volusia County Schools is starting a bicycle education program for students this fall. The intersection of SR 40 and Williamson Blvd. will be connected with Accessible Pedestrian Signals on all corners.

#### B) Presentation on SunRail

#### **Background Information:**

SunRail is Central Florida's new commuter rail system which will connect DeLand in Volusia County to Poinciana in Osceola County when it's fully completed in 2016. Phase 1 is under construction now and will connect DeBary with Sand Lake Road, near the Orlando International Airport.

Phase 1 is 32 miles long and comprises 12 stations. Phase 2, which will begin construction in summer 2014, will extend the line north to DeLand and south into Poinciana. SunRail is a commuter rail system, which means its primary purpose is to get people from home to work, and then back home again, while providing an alternative to driving I-4 every day. The peak operating hours are going to be when I-4 is at its worst: 5:30 – 8:30 a.m. and 4:00 – 7:00 p.m. During those times, trains will run every half hour. During off peak, trains will run every two hours. The last trains will start their trip from the ends of the line between 9:00 and 9:15 p.m. so they can be done and off the tracks by 11:00 p.m.

The base fare for SunRail is \$2.00 with a \$1.00 zone charge for each county line crossed. For example, a trip from DeBary to downtown Orlando will cost \$4.00 one way, since it will include crossing from Volusia into Seminole and then Orange counties. Daily commuters can take advantage of frequent-rider discounts through weekly, monthly or annual passes. The monthly pass for a DeBary to Orlando commute is \$112.00, or 32 percent savings over buying one-way passes each day. Other discounts will be available for seniors, persons with disabilities, students and children.

#### The Peter K. O'Rourke Special Achievement Award

The **Peter K. O'Rourke Special Achievement Awards** recognize notable achievements in the field of highway safety during the prior calendar year by individuals, coalitions, organizations, nonprofit groups, businesses, media, government agencies, universities, or programs.

#### 2013 Winner: Florida DOT Bicycle/Pedestrian Focused Initiative



In 2010, Florida's pedestrian fatality rate was the highest in the nation, at 2.58 deaths per 100,000 population. Pedestrian deaths accounted for 22 percent of all traffic fatalities in the state, claiming 499 lives. Recognizing the need to improve safety for these vulnerable roadway users, the Florida Department of Transportation's (FDOT) Bicycle/Pedestrian Focused Initiative commenced in late 2011.

Led by a team of FDOT officials and representatives from law enforcement, public health, driver licensing, emergency services, tourism, and roadway user groups – the newly formed Florida Pedestrian and Bicycle Coalition, the data-driven program focused resources where opportunities for improving pedestrian and bicycle safety were the greatest. A comprehensive analysis of crash data identified the top 10 highest priority counties, including Miami-Dade and Hillsborough (Tampa/St. Petersburg/ Clearwater), and targeted high visibility enforcement, including saturation patrols at intersections and in crosswalks.

In addition to enforcement, the Coalition also developed the state's first branded, pedestrian/bicycle education campaign, dubbed *Alert Today Alive Tomorrow*. The campaign, which has a goal of increasing awareness of pedestrian and bicycle laws by five percent in the first year of implementation, featured paid media and outreach activities. Team members hosted and participated in numerous community events in the priority counties, distributing t-shirts, tip cards and rewards to those who exhibited appropriate crosswalk behavior. Grassroots pedestrian safety presentations (*WalkWise*) and bicycle safety courses (*BikeSmart*) were also conducted to reach citizens in Tampa and other communities.

A one-stop website – <a href="www.alertodayforida.com">www.alertodayforida.com</a> – was developed to provide easy access to Florida laws and safety tips for pedestrians and bicyclists. The content was updated regularly and a series of public service announcements were developed and housed on the site. The Coalition also partnered with the Daytona International Speedway and NASCAR during high tourist and pedestrian periods to generate awareness about the campaign among the residents of and visitors to Volusia County.

The University of South Florida (USF), located in Tampa, also joined the effort. Not only did USF assist the team in developing the state's first Pedestrian/Bicycle Strategic Safety Plan, but it also conducted a "Bulls Walk and Bike Week" to improve pedestrian and bicycle safety on what is one of the nation's largest university campuses.

All of these activities were monitored to determine impact. From observational and public opinion surveys to ongoing crash data analysis, the team remained focused on taking a data-driven approach to improving pedestrian and bicycle safety in Florida. That effort yielded significant findings that are beneficial not only to Florida, but also to other states seeking to develop and implement a similar initiative. For example, data collected from the observational and public opinion surveys confirmed that awareness of pedestrian and bicycle laws by roadway users is fairly high, but compliance is low. That information helped inform the campaign message and the HVE activities, which sparked strong media coverage.

After the first full year of implementation, the Bicycle/Pedestrian Focused Initiative is yielding positive results. Pedestrian and bicycle fatalities decreased 6.24 percent and 12.5 percent, respectively, from 2011 to 2012. Awareness of safe walking and bicycling behaviors also increased from 20 to as much as 80 percent as a result of the grassroots education. Following a weeklong educational campaign at the USF campus, there was an 11 percent increase from drivers, a 34 percent increase from pedestrians and a 94 percent increase from bicyclists on the perceived yielding behaviors of drivers who encountered pedestrians and bicyclists on the road.

Both NHTSA and FHWA funds were leveraged to mount this comprehensive educational and enforcement effort. Due to Florida's large size and cultural diversity, the Coalition was strategic in their approach, naming "district" champions who were tasked with identifying and addressing the specific needs of their respective areas. The Coalition also convened roundtables across the state to garner stakeholder input and support, as well as led the effort to update the vulnerable users emphasis area in Florida's Strategic Highway Safety Plan. Their approach, which has prompted inquiries from other states, is laying a solid foundation for improving pedestrian and bicycle safety throughout Florida.

# What are Walking School Bus?

Walking School Bus are groups of young people in grades K-8 who walk to school together under the supervision of trained adult volunteers. Walking School Bus travel along a pre-planned route, typically no longer than one mile, picking up youth at different "stations" until they arrive at the school. Groups can meet anywhere from one morning per month to twice daily depending on the level of interest.

#### Why is this program needed?

Walking School Bus have real world tangible benefits for your community. Participating youth learn pedestrian safety, engage in increased physical activity, and make new friends. The community benefits through decreased traffic congestion and improved air quality. Simply put — it's a win win!

#### What type of support is provided?

Participating schools will be assigned a member of our staff to serve as their "Coach".

Coach's oversee youth enrollment, manage program volunteers (including recruitment, training and supervision), develop walking routes, and work to ensure ongoing program quality. Schools will also receive program supplies and recognition materials as they become available.

#### What is required from schools?

In order for a school to adopt the Walking School Bus program we require the following commitment: (1) appoint a school liaison (2) promote the program through school communication channels, and (3) conduct volunteer screening through your local school district.





#### How do I start a group?

To be successful, a Walking School Bus requires support from your local community. We suggest contacting your principal and school PTA to gauge their interest in the program. Factors to consider include the walkability of your neighborhood, the number of interested kids, and the level of community support.
