Introduction

Federal laws and regulations require metropolitan planning organizations (MPOs) to be designated for each urban area with a population greater than 50,000 people [23 CFR 450.310(a), 23 USC 134(d)]. This designation is accomplished by agreement between the Governor and the affected units of local government. The federal rules allow the states and units of local government to largely determine the specific composition of the MPOs. In Florida, Section 339.175, Florida Statutes, provides the requirements for MPO membership composition and apportionment of the voting membership. Pursuant to these state and federal rules, the River to Sea Transportation Planning Organization was formally created in 1977 as the Volusia Coastal Area Metropolitan Planning Organization (MPO) and only included the eastern coastal area of Volusia County. In 1988, the planning area boundary was expanded to include all of Volusia County, recognizing that the western part of Volusia County would be designated an urbanized area with the release of the 1990 Census data and the name of the MPO was changed to the Volusia MPO. In 2004, following the release of the 2000 Census data, it was necessary to adjust the planning boundary to include Flagler Beach and Beverly Beach in Flagler County which had been designated urban as part of the Daytona Beach – Port Orange Urbanized Are and the name of the MPO was changed to the Volusia Transportation Planning Organization (TPO). In 2014, the TPO again adjusted its boundaries, as a result of the expanded Palm Coast – Daytona Beach – Port Orange Urbanized Area following the 2010 Census, to include portions of the Cities of Palm Coast and Bunnell and unincorporated Flagler County and changed its name to the River to Sea TPO.

The following process was followed in considering and updating the TPO Metropolitan Planning Area Boundary and Board Membership:

 River to Sea TPO staff gave a presentation at the June 20, 2023 CAC/TCC Meetings and the June 28, 2023 TPO Board Meeting which included an overview of the process, timeline, federal/state guidelines and required content of the Apportionment Plan.

- River to Sea TPO staff gave a presentation and held a discussion at the August 15, 2023
 CAC/TCC Meetings and the August 23, 2023 TPO Board Meeting which included preliminary boundary map and voting membership scenarios for consideration.
- River to Sea TPO staff gave a presentation and held a discussion at the September 19, 2023 CAC/TCC Meetings and the September 27, 2023 TPO Board Meeting which included a refinement of the boundary map and voting membership scenarios for consideration and discussions on the weighted vote structure. TPO staff was directed to draft an Apportionment Plan as provided in this document, adjusting the TPO boundary to include all of Flagler County, adding an additional Flagler County member, splitting the Small City Alliance into two groups and removing the weighted voting structure.
- River to Sea TPO staff gave a presentation at the October 2, 2023 meeting of the Flagler County Board of County Commissioners which included an overview of the Apportionment Plan scenarios and TPO Board recommendation. Support was provided by the Flagler Board of County Commissioners to include all of Flagler County within the TPO Metropolitan Planning Area and an additional Flagler County member.
- River to Sea TPO staff presented the proposed changes contained in the Apportionment Plan to the CAC and TCC at their meetings held on October 17, 2023.
- River to Sea TPO staff presented the proposed Apportionment Plan to the TPO Board for approval on October 25, 2023.

Metropolitan Planning Area Boundary

The boundaries of the MPA are determined by agreement between the MPO and the Governor and, at minimum, encompass the entire existing urban area (as defined by the Census Bureau) plus the contiguous area expected to become urban within a 20-year forecast period (23 CFR 450.312).

The current boundary of the River to Sea TPO encompasses all of Volusia County, including the cities of Daytona Beach, Daytona Beach Shores, DeBary, DeLand, Deltona, Edgewater, Holly Hill,




Figure 1: River to Sea TPO - Existing Metropolitan Planning Area Boundary Map

Lake Helen, New Smyrna Beach, Orange City, Ormond Beach, Pierson, Oak Hill, Ponce Inlet, Port Orange, South Daytona, and the developed areas of eastern Flagler County, including Beverly Beach and Flagler Beach, as well as portions of the cities of Palm Coast and Bunnell, as shown in Figure 1. The land area of the current planning boundary is approximately 1,186 square miles.




Figure 2: River to Sea TPO - Proposed Metropolitan Planning Area Boundary Map

The proposed River to Sea TPO Boundary will expand to include all of Flagler County, including the town of Marineland, and cover both Volusia and Flagler Counties in their entirety within the MPA, as shown in Figure 2. The land area of the proposed planning boundary is approximately 1,586 square miles.

TPO Population

Table 1 displays the change in population in the River to Sea TPO area between the 2010 and 2020 Census. Between the 2010 Census and the 2020 Census, the population for Volusia and Flagler Counties increased by 11.9% and 20.6%, respectively.

Current & Proposed TPO Membership

Currently, the River to Sea TPO board is comprised of 19 voting members, representing both Volusia and Flagler Counties, 20 Municipalities and six (6) non-voting advisors as shown in Table 2. Of the 19 voting seats, six (6) are allocated to County representation, five (5) to Volusia County and one (1) to Flagler County; 12 are allocated to the largest cities by population (Deltona, Palm Coast, Daytona Beach, Port Orange, Ormond Beach, DeLand, New Smyrna Beach, Edgewater, DeBary, South Daytona, Holly Hill, and Orange City); and the remaining seat is allocated to the Small City Alliance which is comprised of the eight smallest cities by population (Flagler Beach, Daytona Beach Shores, Ponce Inlet, Lake Helen, Bunnell, Oak Hill, Pierson, and Beverly Beach) and share one rotating vote. The TPO currently has a weighted voting structure with one-third of the total vote divided among the six (6) county representatives. The remaining two-thirds vote is distributed (based on population) among the municipalities. The composition of the board was agreed to by the MPO members in a membership apportionment plan approved by the Governor in 2014.

The proposed River to Sea TPO Board membership in this apportionment plan is also shown in Table 2 and increases the voting membership to 21, which includes an additional Flagler County member and splits the Small City Alliance into two groups, one (1) that represents the Volusia County small cities (Daytona Beach Shores, Ponce Inlet, Lake Helen, Oak Hill, and Pierson) and one (1) that represents the Flagler County small cities (Flagler Beach, Bunnell, Beverly Beach, and Marineland). The current weighted voting structure is revised such that each seat equals one vote of equal weight.

RESOLUTION NO. 2023-18

A RESOLUTION OF THE RIVER TO SEA TRANSPORATION PLANNING ORGANIZATION SUPPORTING THE ADOPTION OF THE TPO MEMBERSHIP APPORTIONMENT PLAN.

WHEREAS, the River to Sea Transportation Planning Organization (TPO) is the agency designated to conduct a continuing, coordinated, and comprehensive transportation planning process in Volusia County and portions of Flagler County inclusive of the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell; and

WHEREAS, Section 134 Title 23 of the United States Code requires the designation of MPOs in urban areas, as defined by the United Census Bureau of the Census; and

WHEREAS, Section 134 of Title 23 of the United State Code sets forth membership requirements for MPOs designated for transportation management areas with a population of 200,000 or more residents; and

WHEREAS, the River to Sea TPO met on October 25, 2023 to review its voting composition and agreed on the composition presented herein; and

WHEREAS, Section 339.175(4)(a), Florida Statutes, requires the Governor to review the composition of the Metropolitan Planning Organizations membership in conjunction with the decennial census.

NOW, THEREFORE, BE IT RESOLVED, that the River to Sea TPO approves the submittal of the TPO Membership Apportionment Plan to the Governor's Office.
