I. Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance

The River to Sea Transportation Planning Organization (TPO) Bicycle/Pedestrian Advisory Committee (BPAC) meeting was called to order at 2:00 p.m. by Chairperson Ted Wendler. The roll was called, and it was determined that a quorum was physically present. The meeting was held in a hybrid format with thirteen voting and one non-voting member physically present, and two voting and one non-voting member virtually present.

The Pledge of Allegiance was given.

MOTION: A motion was made by Mr. Hall to allow members attending virtually to participate and vote. The motion was seconded by Mr. Mostert and carried unanimously.

II. <u>Public Comment/Participation</u>

There were no public comments.

III. Action Items

A. <u>Review and Recommend Approval of the September 13, 2023 BPAC Meeting Minutes</u>

MOTION: A motion was made by Mr. Hall to approve the September 13, 2023 BPAC meeting minutes. The motion was seconded by Mr. Coletti and carried unanimously.

Mr. Harris called attention to the third bullet on page 88 of the BPAC agenda and read it into the record, "The TPO Board approved Consent Agenda Item D, Bicycle/Pedestrian Advisory Committee Report, with discussion of the BPAC's request to draft correspondence expressing their concerns at not being consulted prior to an alternative on the Nova Road Coalition Corridor Improvement Project being selected; approved a motion to report to the BPAC the TPO Board's discussion respectfully acknowledging their concerns but declining the drafting of correspondence." He stated there is not an item on the agenda that addresses the correspondence previously requested by BPAC for that reason.

B. <u>Review and Recommend Approval to Amend the List of Shared-Use Non-Motorized (SUN) Trail Projects</u>

Mr. Tim Baylie, Director of Volusia County Parks, Recreation, and Culture gave a PowerPoint presentation requesting an amendment to the List of Shared-Use Non-Motorized (SUN) Trail Projects. Mr. Baylie began by giving a SUN Trail update that included Senate Bill 106 which was signed by the Governor on April 11, 2023. The new bill increased SUN Trail's recurring funding from \$25 million to \$50 million and added \$200 million in non-recurring funds allocated to the SUN Trail program for trails in the SUN Trail network. This allows for the development of trails in the Florida Wildlife Corridor. Mr. Baylie gave in-depth details of Senate Bill 106 and its requirements for SUN Trail projects. The bill allows for paved trails such as asphalt, concrete, or other hard-packed surfaces on disturbed lands in the corridor but that does not include conservation land. He is proposing a Wildlife Corridor Connection to the Coast-to-Coast Trail and the use of articulated concrete in the areas of conservation land.

Mr. Baylie answered BPAC members' questions regarding what they could do to help get the trail built; what would keep the articulated concrete pavers from offsetting; how many miles that type of surface would be needed; and who owns the land.

MOTION: A motion was made by Mr. Lodge to approve amending the List of Shared-Use Non-Motorized (SUN) Trail Projects. The motion was seconded by Mr. Storke and carried unanimously.

IV. <u>Presentation and Discussion Items</u>

A. <u>Presentation and Discussion of the LPGA Blvd. Project Development and Environment (PD&E) Study from US</u> <u>92 to Williamson Blvd.</u>

Mr. Mark Trebitz, FDOT, gave a PowerPoint presentation on the LPGA Boulevard Project Development and Environment (PD&E) Study, from US 92 to Williamson Boulevard. He reviewed the project's purpose and need. He showed the alternatives that were evaluated, and the corridor improvements being proposed. He also reviewed the Tomoka River Bridge improvements along with many of the I-95 improvements. He noted that the improvements would include three roundabouts and reviewed the benefits of those. He discussed the environmental evaluation and presented the preferred alternative.

Mr. Trebitz answered BPAC members' questions regarding the timeline of the project; pedestrian crosswalks at the roundabouts and between US 92 and Tomoka Farms Road; accessible pedestrian signals at crossings; shared-use paths being ADA accessible; bicycle/pedestrian traffic on both bridges; and if there will be bike lanes included in the roundabouts.

B. Presentation and Discussion of Bike/Walk Central Florida's Best Foot Forward Pedestrian Safety Program

This item was postponed until the November meeting.

C. Presentation and Discussion of River to Sea TPO FY 2022/23 Public Outreach Summary

Ms. Blankenship gave a PowerPoint presentation on the TPO's FY 2022/23 Public Outreach. She gave statistics on the attendance of all the advisory committees of the TPO; the TPO's website; and social media platforms. She mentioned that the TPO's monthly newsletter goes out to an average of 675 different organizations. Last year, the TPO attended 31 outreach events which is a 29% increase over the previous year. She provided highlights of some of the different outreach events the TPO participated in during the last year and noted that the TPO partnered with FDOT for many of those events.

Mr. Aufdenberg noted that he used to write letters to the editor of the News-Journal; however, they no longer accept letters to the editor.

D. <u>Presentation and Discussion of the River to Sea TPO's Guiding Resolutions and Project Applications for the</u> <u>Call for Projects</u>

Mr. Harris gave a presentation on the TPO's Priority Project Process. He reviewed the three guiding resolutions in detail. He discussed the local match guidelines and project policies for cost increases, project categories, and ranking, and allocated TPO set-aside funding. He noted that the TPO reaffirms these resolutions every year with minor changes. He discussed the three different types of project applications and the schedule of the priority process. The BPAC Project Review Subcommittee met on September 29, 2023, and recommended improvements; the TPO Board will meet on December 6, 2023, to approve the resolutions and applications. The call for projects opens in early December and will remain open until late February. The BPAC Project Review Subcommittee will meet soon after that to review and score the applications received. The TPO should have a draft List of Prioritized Projects to present by May of 2024 and the adoption of the List of Priority Projects will occur in June of 2024. Once the list is adopted by the TPO Board, the TPO staff will submit it to FDOT no later than June 30, 2024. Mr. Harris reviewed the changes recommended by the BPAC Project Review Subcommittee, noting that there were no changes for the guiding resolutions, only recommended changes for the General Instructions and Application for Bicycle/Pedestrian Projects.

Discussion ensued regarding incomplete applications and the policies/procedures followed for those incomplete applications.

Mr. Harris noted that every year, the TPO holds a workshop at the TCC meeting (as the TCC members are often the ones completing the applications) to answer questions regarding the applications. TPO staff is always available to help with the applications.

V. Staff Comments

Mr. Harris stated he received verification from Volusia County staff that aside from a narrow-paved shoulder along Lexington Boulevard there are no other bicycle/pedestrian facilities and no plans to incorporate any facilities anytime soon.

Ms. Blankenship provided detailed information for the Mobility Week events.

Ms. Nicoulin gave an update on the Apportionment Plan/Urban Area Boundary. She reviewed the current TPO boundary and announced that the TPO is looking at incorporating all of Flagler County, adding one additional Flagler County representative and splitting the Small City Alliance into a Flagler County Small City Alliance and a Volusia County Small City Alliance. Doing that would make a twenty-one-voting-member board versus a nineteen-voting-member board. The weighted vote structure being proposed is one vote per member instead of weighting by population. She presented the Apportionment Plan to the Flagler County Board of County Commissioners, and they are in favor of incorporating all of Flagler County. It will be mid-year of 2024 before it goes into effect.

Ms. Nicoulin also provided an update on the TPO Board's discussion on September 27, 2023, regarding the BPAC correspondence requested to be drafted at last month's meeting on the Nova Road Coalition Project. She explained that the reason the presentation was not provided to the BPAC earlier was due to the timeframes not lining up as there were no committee meetings in the month of July. The TPO Board discussed and acknowledged the concerns of the BPAC but concluded that they respectfully declined draft correspondence. The TPO Board does not want the committees' schedules to delay FDOT's processes and projects. She noted that the BPAC does have representation on the TPO Board as a non-voting advisor. She added that the TPO appreciates the BPAC's input on all things.

Ms. Nicoulin noted that the TPO recently went through their Federal Certification and one of the best practices identified in the report was that the TPO proactively assessed transportation systems for vulnerabilities and incorporated safety and resilience factors into their priority transportation projects. The TPO truly appreciates all the time and effort that the BPAC members and other committee members provide.

Ms. Belin stated that she had spoken with Mayor Partington about this since the last TPO Board meeting.

Mr. Daun asked who made the motion not to provide correspondence on the Nova Road Coalition Project.

Ms. Nicoulin and Mr. Harris stated that they would find out and get that information back to Mr. Daun.

Mr. Leal stated that the issue is not the correspondence, the issue is the communication with FDOT and their lack of consultation with BPAC.

Mr. Mostert asked if there is any way for small communities to pull together to fund projects, considering the small cities can't always afford the \$250,000 minimum amount for funding.

Ms. Nicoulin stated that FDOT does allow bundling of projects but that is for individual cities. The challenge is that staff resources are limited in the smaller municipalities.

VI. <u>BPAC Member Comments</u>

Mr. Daun stated that he was disappointed to see that Mr. Baylie did not address the Volusia County Trails Master Plan at the BPAC meeting. He mentioned the danger of bicyclists in the bike lane wearing dark clothes with flashlights on LPGA Boulevard and suggested an off-road shared-use path. He stated that it was a pleasure to serve on BPAC and introduced his replacement member, Ms. Elizabeth Bonds.

Ms. Bonds stated that she is a nurse practitioner at Halifax and has worked in the Emergency Room for many years and that she wants to be part of fixing the problems. She noted that she is active in bicyclists' groups and a run group and loves the outdoors.

Mr. Storke reminded everyone of the Port Orange Family Days and encouraged the members to volunteer.

Ms. Ardito announced the Florida Bicycle Association Summit as well as the Ride, Walk, and Roll event being held the day after Thanksgiving in Green Springs Park; she passed out a flyer.

Mr. Lodge mentioned the location in DeBary where three main trails cross: the Heart to Heart, Coast to Coast and River to Sea Loop trails. He added that the location is the most dangerous intersection to cross on a bicycle.

Mr. Coletti stated that he attended the pedestrian bridge ribbon cutting in Flagler County a couple of weeks ago. There is a new trailhead that is almost completed near Belle Terre Parkway and the Lehigh Greenway Trail. He added that there have been three bicycle deaths recently in Flagler County. He noted that he is still the only representative from Flagler County on the BPAC.

Mr. Hall thanked Ms. Blankenship for mentioning the White Cane Day and noted that they plan to add disability awareness this year.

Mr. Aufdenberg stated that time falls back before the next meeting which means it gets dark an hour earlier. He announced that he and BPAC Chair Mr. Wendler will be giving out bike lights at Embry-Riddle Aeronautical University and noted that the members can do this in their own communities as well. He also stated that the Publix at Clyde Morris Boulevard and Beville Road hasn't had any bike parking in two months, but they are working on adding it. The southern end of the Daytona Beach River Esplanade is now open, which means the East Coast Greenway is now completely open in Daytona Beach from the southern border to the northern border.

Ms. Sharpe noted that there are no bikes allowed on the paths nor are pets allowed inside the new park south of International Speedway Boulevard.

BACKGROUND INFORMATION:

Flagler County is requesting the addition of two trails to the River to Sea TPO's List of Shared-Use Non-Motorized (SUN) Trail Projects, Tier B.

The first proposed trail, the Old Kings Road Trail, will start at the Volusia/Flagler County line and end at the Palm Coast Linear Trail along Palm Coast Parkway.

The second proposed trail, the Old Brick Road Trail, will start at the intersection of the Lehigh Trail and US 1 and end at the Flagler/St. Johns County line. This trail will provide a connection to the Florida Wildlife Corridor.

- **SUBJECT:** Shared Use Nonmotorized (SUN) Trail List of Priority Projects Addition of Old Kings Road and Old Bricks Road Trails in Flagler County

We request the following two trail alignments in Flagler County to be added to the R2CTPO SUN Trail list of priority projects:

- 1) The Old Kings Road Trail (from Palm Coast Pkwy to Flagler/Volusia County Line) has been recently added to the SUN Trail Network. Development of a multi-use trail along the Old Kings Road corridor has been a priority for Flagler County under its Transportation Alternative Program. The addition of Old Kings Road Trail to the SUN Trail Network will provide further funding opportunities for advancing the planning and implementation for completing the development of the trail and making improvements to the existing trail sections.
- 2) The proposed Old Brick Road Trail (from St. Johns/Flagler County Line to US-1) is within the Florida Wildlife Corridor in Flagler County that would link to the existing Lehigh Trail and the SUN Trail Network at the Old Kings Road Trail. Revitalization of historic Old Brick Road for multi-use trail has been a priority project for Flagler County under its Transportation Alternative Program. The proposed project study would investigate and evaluate alternatives for revitalization of historic Old Brick Road for recreational multi-use trail.



WHEREAS, the River to Sea TPO's adopted TIP is required to be consistent with the Florida Department of Transportation's adopted Five-Year Work Program; and

WHEREAS, the Florida Department of Transportation has provided additional information to the River to Sea TPO regarding the FDOT adopted Five-Year Work Program.

2024 Application for Project Prioritization General Instructions for Bicycle/Pedestrian Project Applications

December 2023

General Instructions:

For the 2024 Call for Projects, the R2CTPO is accepting applications for Feasibility Studies and Project Implementation.

Feasibility studies assess the engineering and planning characteristics of bicycle/pedestrian projects. Feasibility studies must include, but not be limited to, the determination of available right-of-way, documentation and identification of the solutions of obstacles that may impede the project's constructability, permitting and socioeconomic constraints, landscaping, drainage and an engineer's estimate of related planning, design, right-of-way and construction costs.

The R2CTPO has two different application forms for Bicycle/Pedestrian Projects. One is to be used when applying for a Feasibility Study; the other is to be used when applying for Project Implementation. For a given project, applications for Feasibility Study and Project Implementation must be submitted in separate application cycles.

When applying for Project Implementation, the applying agency will also be required to submit a completed copy of FDOT's Project Information Application Form. No project will advance beyond a Feasibility Study unless the R2CTPO receives an application for prioritization of the Project Implementation phase. Applications for prioritization of the Project Implementation phase will be accepted only if a Feasibility Study has already been completed or if the project does not require a Feasibility Study. The applying agency is required to use the minimum threshold programming amount of \$250,000 for design (phase 38), right-of-way (phase 48), and construction (phase 58). There is no minimum threshold programming amount for construction engineering inspection (CEI). If the minimum threshold programming amount is not met for any project phase, the applying agency MUST submit an exception request with the project application. The exception request MUST contain the following information:

- What exception is being requested?
- Who is requesting the exception?
- Why is the exception being requested?
- How will the project proceed if the exception is not granted?

Applications will be ranked based on the information supplied in the application. The TPO is not obliged to consider information pertaining to the project request that is not included in the project application. However, applying agencies are encouraged to be present for the evaluation of their applications to provide clarification, if needed. Mixed projects (defined as a project that is not a stand-alone bicycle/pedestrian project) require separate applications for the bicycle/pedestrian category and traffic operations/safety category. Updated cost

estimates for projects on the bicycle/pedestrian list of prioritized projects are to be submitted with a letter of continuing support by February 29, 2024. After the List of Prioritized Projects is adopted by the R2CTPO Board in June, if a project is withdrawn by the sponsor, an official letter of withdrawal and/or email must be submitted to the R2CTPO within thirty (30) days.

INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED!

Eligible Project Sponsors for the 2024 Call for Projects.

- Local governments;
- Transit agencies;
- School districts or educational institutions;
- Any other local or regional governmental entity with responsibility for oversight of transportation or recreational trails (other than a metropolitan planning organization or a State agency) that the State determines to be eligible.

Eligible activities related to surface transportation that can be funded with **Transportation Alternatives funds**¹:

- Construction, planning, and design of on-road and off-road trail facilities for pedestrians, bicyclists, and
 other non-motorized forms of transportation, including sidewalks, bicycle infrastructure, pedestrian and
 bicycle signals, traffic calming techniques, lighting, signage, and other safety-related infrastructure, and
 transportation projects to achieve compliance with the Americans with Disabilities Act of 1990.
- Construction, planning, and design of infrastructure-related projects and systems that will provide safe routes for non-drivers, including children, older adults, and individuals with disabilities to access daily needs.
- Construction, planning, and design of infrastructure-related projects on any public road or any bicycle
 or pedestrian pathway or trail in the vicinity of schools that will substantially improve the ability of
 students to walk and bicycle to school, including sidewalk improvements, traffic calming and speed
 reduction improvements, pedestrian and bicycle crossing improvements, on-street bicycle facilities, offstreet bicycle and pedestrian facilities, secure bicycle parking facilities, and traffic diversion
 improvements.

All construction and pre-construction work phases will be administered by the Florida Department of Transportation (FDOT) or other Local Agency Program (LAP) certified local government. Reimbursements are distributed only to a LAP certified agency responsible for completing the tasks. FDOT assigns a LAP Design and LAP Construction Liaison for each project. Federal law requires that each project be administered under the rules and procedures governing federally funded transportation projects. Certified Local Agencies comply with all applicable Federal statutes, rules and regulations.

- a. inventory, control, or removal of outdoor advertising;
- b. **historic** preservation and rehabilitation of historic transportation facilities;
- c. vegetation management practices in transportation rights-of-way to improve roadway safety, prevent against invasive species, and provide erosion control; and
- d. archaeological activities related to impacts from implementation of a transportation project eligible under title 23;

4. Safe Routes to School coordinator

¹ It is the River to Sea TPO's intent to extend eligibility to all of the activities included within the meaning of the term "Transportation Alternatives" pursuant to 23 U.S.C. 101(a)(29) except the following:

^{1.} Construction of turnouts, overlooks, and viewing areas;

^{2.} Community improvement activities, including -

^{3.} Any environmental mitigation activity, including pollution prevention and pollution abatement activities and mitigation to –

a. address stormwater management, control, and water pollution prevention or abatement related to highway construction or due to highway runoff, including activities described in sections 133(b)(11), 328(a), and 329 of title 23; or

b. reduce vehicle-caused wildlife mortality or to restore and maintain connectivity among terrestrial or aquatic habitats

^{5.} Planning, designing, or construction boulevards and other roadways largely in the right-of-way of former Interstate System routes or other divided highways.

Initial Project Screening:

Any project submitted by a local government for consideration needs to meet the following screening criteria:

For any proposed facility to be considered eligible through the TPO process, the project <u>must be</u> included on the *River to Sea TPO's Bicycle and Pedestrian Plan <u>https://www.r2ctpo.org/planning-studies/bicycle-pedestrian/draft-bicycle-pedestrian-plan/</u> or a local government adopted <i>Bicycle/Pedestrian Plan* or the *River to Sea TPO's Bicycle Suitability Map 2019.*

Is this *Shared Use Path* project at least 12 feet wide?

- If **Yes** the project is eligible.
- If No justification is required to determine eligibility.

Is this *Sidewalk* project at least 5 feet wide?

- If **Yes** the project is eligible.
- If **No** the project application is not acceptable.

Is this an activity that can be funded with Transportation Alternatives Funds?

- If **Yes** the project is eligible.
- If **No** the project application is not acceptable.

Local Match Requirement:

R2CTPO Resolution 2023-## provides that the governmental entity requesting state and/or federal transportation funds shall be required to match those funds programmed on the project with local funds at the ratio of 10% local funds to 90% state and/or federal funds. This match requirement shall not apply to projects on the State Highway System. The match shall be by project phase for each programmed phase including feasibility study. A non-federal cash match is required for a feasibility study. For all other phases, the local match is defined as non-federal cash match and/or in-kind services that advance the project. This resolution also reaffirms the R2CTPO's policy that the applying agency (project originator) shall be responsible for any cost overruns encountered on a project funded with state and/or federal transportation funds unless the project is on the state highway system, in which case, the State DOT shall be responsible for any cost overruns.

Other Funding Requirements:

All project applications are subject to approval by the R2CTPO Board. Other funds (in addition to SU funds) may be used to fund project phases or overall costs.

Electronic and "Hard Copy" Submittal Requirements:

Any project submitted by a local government for consideration MUST include the following information/materials:

1. Applications and supporting documentation shall be submitted as digital media in Portable Document Format (PDF).

Electronic documents must be submitted through the R2CTPO FTP site: https://www3.mydocsonline.com/customerupload/2792171eab9bca9a833495865c00

- 2. The application and all supporting documentation shall be included in one electronic PDF file.
- 3. All document pages shall be oriented so that the top of the page is always at the top of the computer monitor.

- 4. Page size shall be either 8-1/2" by 11" (letter) or 11" by 17" (tabloid).
- 5. PDF documents produced by scanning paper documents are inherently inferior to those produced directly from an electronic source. Documents which are only available in paper format should be scanned at a resolution which ensures the pages are legible on both a computer screen and a printed page. We recommend scanning at 300 dpi to balance legibility and file size. If you are unable to produce an electronic document as prescribed here, please contact R2CTPO staff to discuss other options. If you are unable to upload to the R2CTPO FTP site, please contact R2CTPO staff to discuss other options.
- 6. In addition to the digital submittal, we require one (1) complete paper copy of the application and all supporting documents. This must be identical to the digital submittal.
- 7. Submit any available right-of-way information.
- 8. Each application MUST include a Project Map that <u>clearly</u> identifies the termini of the project, Proximity to Community Assets and Network Connectivity through the use of a one (1) mile radius buffer for Shared Use Path projects and Transportation Alternatives Activities and a one-half (½) mile radius buffer for Sidewalk projects. Maximum map size is 11" x 17".
- 9. In addition, all maps MUST include a **Scale** (in subdivisions of a mile), **North Arrow, Title** and **Legend**. Photographs are encouraged and must be captioned.

WHEREAS, the River to Sea Transportation Planning Organization (TPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the designated Metropolitan Planning Area {MPA} comprised of Volusia County and the urbanized areas of Flagler County including the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell; and

WHEREAS, 23 C.F.R. 450.104 provides that the River to Sea TPO shall annually endorse, and amend as appropriate, the plans and programs required, among which is the Surface Transportation Block Grant (STBG) Program projects list of the annual Transportation Improvement Program (TIP) submission; and

WHEREAS, each year the appropriate River to Sea TPO committees, made up of a cross-section of interested citizens and technical staff, are charged with the responsibility of drafting a list of prioritized projects; and

WHEREAS, it is the responsibility of the River to Sea TPO to establish project priorities that are equitable for all areas within the River to Sea TPO's planning boundaries; and

The River to Sea TPO's total Surface Transportation Block Grant (STBG) Program Urban Attributable (SU) funding goals will be made in the following manner: 40% of the total SU funds will be used for Traffic Operations, Safety, and Local Initiatives (traffic operations focused) Project Priorities, 30% of the total SU funds will be used for Transit Project Priorities, and 30% of the total SU funds will be used for Bicycle/Pedestrian, Transportation Alternatives, Regional Trails, and Local Initiatives (bicycle/pedestrian focused) Project Priorities; and
- 2. Other state and federal funds identified in the 2045 Long Range Transportation Plan for Local Initiatives will be made available in the following manner: 50% of the funds will be used for Traffic Operations, Safety, and Local Initiatives (traffic operations focused) Project Priorities and 50% will be used for Bicycle/Pedestrian, Transportation Alternatives, Regional Trails, and Local Initiatives (bicycle/pedestrian focused) Project Priorities; and
- 3. Mixed projects (defined as a project that is not a stand-alone bicycle or pedestrian project) will only be accepted and ranked in both the bicycle/pedestrian focused and the traffic operations focused project categories if the bicycle/pedestrian cost component of the project is greater than 20% of the total project cost. Projects that do not meet this threshold shall be submitted and ranked in the traffic operations focused category only. The project applications shall include the cost breakdown between the bicycle/pedestrian component and the traffic operations component of the project. When programming mixed projects, funding amounts drawn down from each set-aside category (bicycle/pedestrian focused vs. traffic operations focused) shall be consistent with the cost component of that category; and
- 4. For projects funded in whole or in part with Urban Attributable (SU) funding and/or other state and federal funds obtained through the TPO's Priority Project Process, if the recipient of the funds chooses to display any signs or markers at the project site, said signs or markers shall include language acknowledging the River to Sea TPO, Florida Department of Transportation (FDOT), Federal Highway Administration (FHWA), Federal Transit Administration (FTA), and/or other funding partners, as may be applicable, for providing funding for the project. In addition to the language, the sign or marker shall include these agencies' official logos; and

WHEREAS, Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition to the receipt of federal capital or operating assistance, have a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, the River to Sea Transportation Planning Organization (TPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the designated Metropolitan Planning Area (MPA) comprised of Volusia County and the urbanized areas of Flagler County including the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell; and

WHEREAS, the FOOT funds projects in the Work Program based on the plans and priorities set by the TPO; and

WHEREAS, the River to Sea TPO desires to provide, whenever possible, financial assistance to governmental entities to allow them to pursue transportation projects and programs which are consistent with the TPO's plans and priorities and benefit residents of and visitors to our planning area; and

WHEREAS, the River to Sea TPO wants to leverage the state and federal transportation funds programmed on transportation projects in TPO's MPA and ensure a measure of local financial commitment to transportation projects and programs utilizing these funds; and

Now, THEREFORE, BE IT RESOLVED by the River to Sea TPO that:

- Every governmental entity receiving state and/or federal transportation funds for a project on any of the following Priority Project lists shall provide a local match at a minimum ratio of 10% local funds to 90% state and/or federal funds:
 - a. Traffic Operations, Safety, and Local Initiatives Projects;
 - b. Bicycle/Pedestrian, Transportation Alternatives, Regional Trails, and Local Initiatives Projects.

This match requirement shall not apply to projects on the State Highway System; and

2. Every governmental entity receiving state and/or federal transportation funds for a project on the TPO's Priority list of Transportation Planning Studies shall provide a local match at a minimum ratio of 10% local funds to 90% state and/or federal funds; and

- 3. A local match shall not be required for any project on the TPO's Priority Lists of Strategic Intermodal System (SIS) Projects, Regionally-Significant Non-SIS Roadway Projects, or Transit Projects, subject to any other funding program requirements that may apply (e.g., Transportation Regional Incentive Program); and
- 4. the River to Sea TPO determines that "local match" shall be defined as non-state/non-federal cash match and/or in-kind services of eligible costs that advance the project in question; and
- 5. notwithstanding the terms prescribed in subparagraph 1 and 2, above, the required local match shall not exceed the ratio required in the current policy of the TPO Board at the time the governmental entity requests funding unless the local government entity commits to a higher local match for the project; and
- 6. the River to Sea TPO reserves the right to waive or adjust the local match requirements if the TPO Board deems there exists sufficient reason or circumstance; and
- 7. the River to Sea TPO defines a cost overrun as an increase in the amount of the cost of any programmed project phase due to a change in scope, project limits or project approach that could have reasonably been foreseen or is the result of an incomplete, insufficient or out of date cost estimate; and
- 8. the River to Sea TPO reaffirms its policy that any cost overruns encountered on a project funded with state and/or federal transportation funds will be the responsibility of the governmental entity identified as the project originator with the following exception: if the project is on the state highway system and the State DOT is the project manager of record then the state shall be responsible for any cost overruns utilizing state dollars; and
- 9. the River to Sea TPO defines a cost increase as an increase in the cost of any programmed project phase due to unforeseen market changes or a change in requirements and/or standards for projects that have current and complete cost estimates; and
- 10. Requests for additional state and/or federal funds must be submitted to the TPO and include a statement of hardship or justification by the governmental entity identified as the project sponsor along with supporting documentation that includes detailed justification of the change in cost; and
- 11. the River to Sea TPO Executive Director may authorize the use of state and/or federal funds to cover some or all of a justified cost increase on any project phase up to and including 50% of the project cost estimate for that phase; and
- 12. the use of state and/or federal funds to cover cost increases exceeding 50% of the project cost estimate for any phase may be authorized only by the River to Sea TPO Board; and
- 13. the policies set forth in this resolution shall remain in effect unless and until they are repealed or amended by the TPO; and

- 1. The project application and evaluation criteria approved by the River to Sea TPO Board shall be used to solicit and evaluate projects for priority ranking in the transportation program categories listed below:
 - a. Florida Strategic Intermodal System (SIS) Projects;
 - b. Regionally Significant, Non-SIS Roadway Projects and Major Bridge Projects

- c. Traffic Operations, Safety, and Local Initiatives Projects;
- d. Bicycle/Pedestrian, Transportation Alternatives, Regional Trails, and Local Initiatives Projects;
- e. Public Transit Projects; and
- f. Transportation Planning Studies.
- 2. River to Sea TPO projects that were previously ranked and have a Financial Management (FM) number and are in the Florida Department of Transportation Work Program will automatically be prioritized above projects that are not currently in the FDOT Five-Year Work Program;
- 3. Projects which are ranked one through eight on Tier "B" of the Prioritized List of Traffic Operations, Safety, and Local Initiatives Projects are deemed to be protected, and will be ranked in their current spot or move to the next available higher spot until they are completed and drop out of the Work Program;
- 4. Projects which are ranked one through three on Tier "B" of the Prioritized List of Bicycle/Pedestrian, Transportation Alternatives, Regional Trails, and Local Initiatives Projects are deemed to be protected, and will be ranked in their current spot or move to the next available higher spot until they are completed and drop out of the Work Program;
- 5. If, at any time, two or more lists of prioritized projects are merged into a new list, every project that was protected prior to the merger shall retain its protected status, and no new or previously unprotected project shall be deemed to be protected unless and until it advances to the protected rank prescribed for the new, merged list;
- The River to Sea TPO will only re-prioritize or add projects when the TPO Board determines:
 a) unusual circumstances support such action, b) the circumstances are not of a recurring nature, c) the circumstances do not result from the actions of the project sponsor, and d) the proposed reprioritization or addition will not be contrary to the public interest;
- Requests to change the priority or to add a project must include a statement of hardship by the requestor along with supporting documentation that includes detailed justification of need and an assessment of the impacts to the programming of prioritized projects;
- 8. It is the responsibility of the River to Sea TPO and FOOT staffs to provide the River to Sea TPO members with current information and data on project status and to assist the members in their efforts to make informed decisions regarding the prioritized projects lists;
- 9. The River to Sea TPO shall, in its discretion, make all decisions regarding the final prioritized project lists that are annually submitted to FDOT;
- 10. Once a project has attained protected status, it should be programmed within 3 years. If it has not been programmed during that time due to inactivity on the part of the project sponsor, then the project will be removed from the list of priority projects. The project sponsor may resubmit the project for open ranking on any subsequent call for projects;

- 11. Per the approved Annual Call for Projects schedule, the project sponsor shall annually submit a letter to the River to Sea TPO affirming their continued support to retain each project on the priority list and provide updated cost estimates for all unfunded phases of each project they sponsor on the Regionally Significant Non-SIS, Tier "A", and Tier "B" project lists. Updated cost estimates for projects or project phases that are currently funded/programmed are considered a request for additional funding and subject to the TPO's cost increase/cost overrun policy. Requests for additional funding shall be submitted to the TPO on the appropriate form. Pending availability of funds, updates to planning level construction costs (CST/CEI) that were programmed prior to completion of the design (PE) phase may be updated one time following the completion of the PE phase without being considered a request for additional funding. The letter shall also provide support from the project sponsor for any Transportation Regional Incentive Program (TRIP) eligible project(s) which they are ready to advance into the Work Program and TIP and provide a commitment of local matching funds, if required and any SUN Trail eligible projects which the local government intends to submit for SUN Trail funding during the State's open call for funding. These projects shall be compiled into an unranked TRIP List and unranked SUN Trail list;
- 12. The River to Sea TPO shall use this project prioritization process to support the development of Regional Priority Lists in the areas of Trails, Transit, Transportation Systems Management and Operations (TSM&O), and Planning Studies;
- 13. The policies set forth in this resolution shall remain in effect unless and until they are repealed or amended by the TPO; and
- 14. the Chairperson of the River to Sea TPO, (or their designee) is hereby authorized and directed to provide a copy of this resolution to the:
 - a. Florida Department of Transportation (FOOT);
 - b. Federal Transit Administration (FTA) (through the Florida Department of Transportation); and
 - c. Federal Highway Administration (FHWA) (through the Florida Department of Transportation).

BACKGROUND INFORMATION:

Each year, FDOT develops the Five-Year Work Program in accordance with Section 339.135, Florida Statutes. The Five-Year Work Program is an ongoing process that is used to forecast the funds available and allocate those to transportation system improvements over a five-year period.

The development of this Work Program involves coordination with local governments, including Metropolitan Planning Organizations and other city and county officials. In urbanized areas, Metropolitan Planning Organizations (MPOs) have the responsibility to develop transportation plans and prioritize transportation needs. In non-metropolitan areas, county commissions establish priorities. FDOT implements the transportation improvements identified by the TPOs and local governments. During the process, new projects are added, and existing projects may be advanced or deferred based on the updated financial forecast. As a new fifth year is added to the cycle, the current year drops out of the plan and a new Five-Year Work Program is introduced.

The online Work Program Public Hearing for District Five was held virtually October 16 - 20, 2023 with an in-person open house held on October 17, 2023.

FDOT Staff will provide a presentation of the tentative Work Program highlighting projects specific to the River to Sea TPO planning area.

Bike/Walk Central Florida, a nonprofit advocacy organization that administers pedestrian and bicycle safety programs across the Central Florida region has recently partnered with the Florida Department of Transportation to bring the Best Foot Forward for Pedestrian Safety program to Volusia County, expanding on its current footprint in Orange, Seminole and Osceola Counties.


The program takes a three "E" approach to educating drivers on the driver yield law and encouraging community members to stop and let people at marked crosswalks cross the street. The program has been ongoing in Orange, Seminole, and Osceola counties for over 10 years with significant results.

RESOLUTION OF THE RIVER TO SEA TRANSPORTATION PLANNING ORGANIZATION SUPPORTING BIKE/WALK CENTRAL FLORIDA'S BEST FOOT FORWARD FOR PEDESTRIAN SAFETY PROGRAM

WHEREAS, the River to Sea Transportation Planning Organization (TPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for Volusia County and portions of Flagler County inclusive of the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell; and

WHEREAS, Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition to the receipt of federal capital or operating assistance, have a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, according to Smart Growth America's Dangerous by Design Report, the Deltona-Daytona Beach-Ormond Beach area is the most dangerous metropolitan area in the United States for people walking between 2016 and 2020, ranked by average yearly deaths per 100,000 people; and

WHEREAS, Bike/Walk Central Florida is a regional advocacy organization for bicyclists and pedestrians; and

WHEREAS, the Best Foot Forward (BFF) for Pedestrian Safety Program is a communitywide grassroots initiative to make walking safer by changing driver's behavior utilizing a "3E" methodology of low-cost Engineering, high-visibility Enforcement, and dynamic public Education, measured by increasing driver yield rates at marked crosswalks; and

WHEREAS, BFF is a regional coalition of civic leaders, public safety officials, engineers, transportation planners, educators, health care professionals, advocates, local businesses, and concerned citizens whose mission is to reduce pedestrian injuries and deaths; and

WHEREAS, Bike/Walk Central Florida's Best Foot Forward for Pedestrian Safety Program, the Florida Department of Transportation (FDOT), and the River to Sea TPO are committed to reducing traffic crashes resulting in serious injuries and fatalities to pedestrians and bicyclists; and

WHEREAS, the Florida Department of Transportation and River to Sea TPO have adopted a target of zero for all transportation safety performance measures (PM 1).

Now, THEREFORE, BE IT RESOLVED by the River to Sea TPO that:

- 1. The River to Sea TPO supports Bike/Walk Central Florida's Best Foot Forward for Pedestrian Safety Program and the expansion of the program into Volusia County; and
- 2. The River to Sea TPO intends to participate in partnership with other local and regional agencies in the Best Foot Forward for Pedestrian Safety Program to reduce pedestrian injuries and fatalities within our communities.

C. PRESENTATION AND DISCUSSION OF VORIDE MOBILITY ON DEMAND SERVICE PROVIDED BY VIA TRANSPORTATION D/B/A RIVER NORTH TRANSIT, LLC

BACKGROUND INFORMATION:

On October 3, 2023, the Volusia County Council approved a five-year agreement with River North Transit, LLC, a subsidiary of Via Transportation, for Mobility-on-Demand (MOD) Services. River North Transit will be responsible for providing Votran a turnkey transportation-as-a-service (TaaS) solution. This includes the software-as-a-service (SaaS) platform and user application, system set-up, hardware installation, training, vehicles, drivers, and other ongoing support services and staff to facilitate the MOD service deployment and operations on behalf of Votran as a new Votran service. The new MOD service is called VoRide.

Customers (existing transit riders and the general public) will use the SaaS platform application to plan, book, pay for, and execute their trip, including connections to fixed-route service. Votran will use the platform to monitor and manage trip delivery, collect data, and generate planning and management reports. VoRide will be fully compliant with the Americans with Disabilities Act (ADA), serve the general public, and serve persons certified eligible for ADA services who elect to use MOD for their mobility service.

VoRide is expected to provide a higher level of services while saving Volusia County an estimated \$1,000,000.00 per year by replacing some of the poor-performing fixed route services. In addition, it will free up resources to be utilized in other areas of the county to increase on-time performance for paratransit customers. The estimated average not-to-exceed costs for MOD services before revenue from fares is \$2,274,337.00 and annual estimated fare revenue is \$198,000.00.

A presentation on the new VoRide Service will be provided by staff from the Volusia County Transit Services Division.




