Notice of Public Hearing for the 2040 Long Range Transportation Plan (LRTP)

Notice is hereby given that the River to Sea Transportation Planning Organization (R2CTPO) will conduct a public hearing at its regular TPO Board meeting on Wednesday, September 23, 2015 at 9:00 a.m. in the River to Sea TPO Conference room located at 2570 W. International Speedway Blvd. Suite 100, Daytona Beach FL. The purpose of the hearing is to receive public input regarding the draft 2040 Long Range Transportation. Public comments are welcomed and encouraged during the public hearing or they may be submitted directly to the TPO office prior to the public hearing by email, mail or telephone.

The R2CTPO invites you to a public hearing for the 2040 Long Range Transportation Plan (LRTP). The 2040 LRTP is a 25-year projection to identify strategies that satisfy the transportation needs of the R2CTPO Metropolitan Planning Area (MPA). This MPA encompasses all of Volusia County and portions of Flagler County inclusive of the cities of Flagler Beach, Beverly Beach, and portions of Palm Coast and Bunnell. Projects selected for inclusion in the 2040 LRTP are intended to reflect the Vision and Goals of the MPA and its member governments.

The LRTP is the guiding document that identifies needed transportation projects and the anticipated federal and state funds that will support their development. Federal law requires the LRTP to be "cost-feasible" so the TPO forecasts federal, state, and local financial resources that will cover the costs of the proposed projects. This update must be adopted no later than September 30, 2015.
