## RIVER TO SEA TRANSPORTATION PLANNING ORGANIZATION (TPO) ANNOUNCES CONNECT 2045 PRELIMINARY COST FEASIBLE PLAN DEVELOPMENT WEBINAR

DAYTONA BEACH, FL — Connect 2045 is the new Long Range Transportation Plan (LRTP) being developed to guide the transportation future of the River to Sea TPO planning area. The 2045 LRTP is a 25-year projection to identify strategies that satisfy the transportation needs of TPO planning area.

As public involvement is an essential component of developing this plan, we are hosting a webinar to gather public input on the development of the Preliminary Cost Feasible Plan. The input received will help shape the 2045 LRTP and identify ways to make sustainable investments in the local transportation network.
