#### **Project Description**

The project involves the widening of SR 40 to four lanes from SR 15/US 17 to west of SR 11. The project includes milling and resurfacing of the existing roadway to serve as westbound travel lanes and new roadway construction for eastbound travel lanes. Work also includes the construction of four wildlife crossing box culverts and a 12-foot wide, paved, multi-use trail on the south side of the road. The project is not funded for right of way or construction.
