

- ➤ "...it is the intent of the Legislature that the department make use of its expertise
 in efficiently providing transportation projects to develop the Florida Shared-Use
 Nonmotorized Trail Network..."
- ➤ "...created as a component of the Florida Greenways and Trails System established in chapter 260."
- ➤ "Network components do not include sidewalks, nature trails, loop trails wholly within a single park or natural area, or on-road facilities, such as bicycle lanes..."
- ➤ The department shall include the Florida Shared-Use Nonmotorized Trail Network in its work program developed pursuant to s. 339.135. For purposes of funding and maintaining projects within the network, the department shall allocate in its program and resource plan a minimum of \$25 million annually(state-wide), beginning in the 2015-2016 fiscal year.

SUN Trail Network Project Tiers:



Individual Trail Projects: 1/3 of SUN Trail fund Allocation


 Trail segments that contribute or connect to the SUN Trail Network; as identified by the FL Greenways and Trails System's Land Priority Network, coordinated by the FL Department of Environmental Protection.

NOTE: An allocation to one project phase is not a guarantee of commitment to allocations for future phases.

Regional Trail System: 2/3 of SUN Trail fund Allocation

Coast to Coast - Identified at December 2015 meeting of the Florida Greenways and Trails Council, an advisory body to the Florida Department of Environmental Protection (FDEP)

St. Johns River-to-Sea Loop - Identified at March 2016 meeting of the Florida Greenways and Trails Council, an advisory body to the Florida Department of Environmental Protection (FDEP)



SUN Trail Eligibility / Requirements

- 1. Project limits within SUN Trail network. (Project Limits Map)
- 2. Jurisdictional Priority (Adopted Priority List)
- 3. Long-term Trail Manager Identification
- 4. Transportation Plan (TIP/STIP)







Eligible project phases that are ready for programming will advance more quickly.


Coast to Coast Trail A Regional Trail System
